

## PDX by the Numbers

- Average number of Departures/Arrivals daily: 678
  - Commercial: 491
  - Cargo: 79
  - Military: 8-12 F-15 aircraft (16-24 operations a day)
- Military:
  - Fly Mon Fri at approx 9:00 am and 1:00pm
  - Monthly weekend and evening trainings
  - "Scrambles"
- Traffic
  - 15 Airlines, 15 Cargo, GA and Military

#### Citizens Noise Advisory Committee

- Formed in 1998 as a Neighborhood voice
  - Port of Portland took action for transparency
  - Very contentious at beginning
  - Trust, Education, Solutions, decision makers attend
- 15 volunteer Reps jurisdictionally appointed
  - City of Portland: 3
  - 4 surrounding Counties: 1 each
  - City of Vancouver: 2
  - City of Troutdale: 1
  - City of Gresham: 1
  - Port Appointments: 4
- Line item Port of Portland budget

#### **CNAC Mission**

CNAC seeks to limit and reduce the impact of aircraft noise related to Portland International Airport (PDX) in consideration of, and respect for, the community's environment, health and quality of life. CNAC also seeks to raise the community's understanding of aviation noise.

- CNAC advises Port staff on community noise issues
- Serves as a resource for community outreach
- Provides a forum for residents to address concerns about aircraft operations & noise
- Provide input related to the PDX Noise Management Program
- Participate on other airport advisory committees
- Assist the Port in promoting public understanding of airport noise issues and awareness of the PDX Noise Management Program

## CNAC's Role & Charge

- Represent Citizen concerns
- Is a Chaired Public Forum Public Records
- Open meetings held every other month (2<sup>nd</sup> Thurs)
- Published meeting notes (Port website)
- Review reported issues, suggest ideas, solutions, proposals for Noise reduction
- Keep appointed jurisdictions informed
- Enhance Citizens understanding of noise
  - Community Outreach
  - Education
  - Recommendations


