# City of SeaTac Regular Council Meeting Minutes

June 10, 2014 6:30 PM City Hall Council Chambers

**CALL TO ORDER:** The SeaTac City Council Regular Meeting was called to order by Mayor Mia Gregerson at 6:29 p.m.

- FLAG SALUTE: Mayor Gregerson led the Council, audience and staff in the Pledge of Allegiance.
- **PUBLIC COMMENTS:** Jean Warner commented on code enforcement complaints on theirs and neighboring properties, and a policy change in how code violations are reported.
  - J.W. Myers invited everyone to a public meeting on June 12 at the SeaTac YMCA regarding the Seattle Outboard Association is proposing to have a power boat race on Angle lake, proposed dates are July 19-20 and August 6-7. Participants are ages 9 to 69 and older and boats will be on display.

## •Literacy Source

Halina Barras stated the mission of Literacy Source is to build a more literate community by providing learning centered instruction to adults in the English language and basic life skills. In SeaTac English as a Second Language (ESL) is offered at Angle Lake Resource Center with childcare provided for maximum participation, adult education, and adult high school programs. Many students are in the program for a few years. It takes approximately 100 hours before you start to see progress in ESL classes. Class participants speak various languages; they work in groups, and have individual plans. There is currently a waiting list in SeaTac. Classes are for 18 years and older. Sessions are eight weeks in length with a two to three week break, and there is no fee. They are financed through the City of SeaTac.

### • Reading, Eating and Summer Learning: Valley View Library service responses to community needs

KCLS Cluster Manager John Sheller and Valley View Librarian Services Manager Darth Nielson presented an overview of the summer learning program and showed a video regarding summer reading <a href="https://www.youtube.com/watch?v=Cyalbzso8CI">www.youtube.com/watch?v=Cyalbzso8CI</a>. Mr. Sheller stated the contents of the video is something the library has been aware of for a while, that is why KCLS continue with summer learning.

Mr. Nielson stated the SeatTac/Tukwila area host the "Lets Read" Program each year. Summer reading sites piggy back on summer feeding sites throughout King County. The book mobile, is brought to the sites and books are handed out. The emphasis this year is "Fizz Boom Read" for elementary and "Spark A Reaction" for teens. In SeaTac robotics classes will be offered for ages 7-12 hosted by the Raisbeck Aviation Robotics team and a puppet show July 11. June 27 Mayor Gregerson will kick off the science and magic event at Valley View Library. Contact Mr. Nielson if interested in volunteering. Valley View Library also has a year round kids read program. The KCLS is nationally recognized and ranks regularly in the top three positions nationally in usage and circulation. KCLS works hard to be a contributing member in the communities it serves.
