About Housing Justice Project

At HJP we focus on providing legal assistance to low income <u>King County</u> tenants facing eviction. If you have received an eviction notice from your landlord we recommend visiting one of our clinics immediately to help you respond in a timely manner.

Services Include:

- ✓ Legal counsel and advice for tenants with eviction related issues
- ✓ Help responding to eviction paperwork
- ✓ Negotiating with landlords/attorneys
- ✓ Representation at eviction (show cause) hearings
- ✓ Referrals and Resource Information

We Do Not Help With:

Issues concerning security deposits, eviction records, small claims court, or repair requests. Our attorneys do not provide on-going representation, legal representation in non-eviction cases, or legal advice over the phone. We do not represent landlords, commercial/business owners, or homeowners.

How to Reach our Services

No appointment is necessary. Come to one of our office locations, listed on the back of this brochure, during clinic hours to meet with an attorney. You will first talk to a legal assistant who will collect information from you before you talk to an attorney. Please arrive early as we see tenants on a first come first served basis. Tenants with an eviction show cause hearing on the same day as their visit to HJP will be helped first.

Interpreters are available upon request.

If you are responding to a court action that has been filed against you, review the paperwork to determine whether the action was filed in the Kent Courthouse or the Seattle Courthouse. If you are unsure where the court action was filed and you live in King County North of I-90 or within the city limits of Seattle, Mercer Island, Bellevue, Issaquah, North Bend, and Vashon and Maury Islands you should go to the courthouse in Seattle. If you live South of I-90 and do not live in any of the cities listed above, you should go to the Kent Courthouse.

How to Prepare for Your Visit

Please come prepared for your visit in order to allow our volunteer attorneys to better assist you. One thing to consider prior to your arrival is whether you want to move or stay in the unit. When possible, write a timeline of events.

Bring <u>ALL</u> documents related to your case including:

- ✓ Rental/Lease Agreement
- ✓ Rent Receipts/Money Orders or Cancelled Checks
- ✓ All paperwork from the landlord or landlord's attorney either posted or mailed (3-day notice, 10-day notice, Summons & Complaint, Order to Show Cause, etc.)
- ✓ All letters or e-mails (any type of communication) to and from the landlord or the landlords attorney
- ✓ Copies of photos documenting conditions of the unit
- ✓ Notify the legal volunteer of any upcoming deadlines
