# City of SeaTac Regular Council Meeting Minutes

July 14, 2015 6:30PM City Hall Council Chambers

**CALL TO ORDER:** The SeaTac City Council Regular Meeting was called to order by Mayor Mia Gregerson at 6:30 p.m.

## King County (KC) Sexual Assault Resource Center (KCSARC)

Executive Director Mary Ellen Stone thanked SeaTac for its support. In 2014, KCSARC served 46 clients. So far in January through June 2015, 39 clients have been served. The contract goal is 26. Contract hours provided in 2014 was 400 hours. January through June 2015, 425 hours have been provided. The contract goal for hours in 2014 was 94 hours and in 2015 it was 79 hours. She shared a story of a woman who received support from the center.

Discussion ensued regarding the possible reason for the increase in need and how to help empower the community.

Ms. Stone stated that parents talking to kids is the most important.

## Adopting a 6-year Transportation Improvement Plan (TIP)

Mayor Gregerson opened the PH at 6:46 p.m.

PW Director Gut stated that this item was presented at the June 23 CSS. He noted one change since that meeting, the connecting 28<sup>th</sup>/24<sup>th</sup> Avenue South Project dollar figures were updated.

Discussion ensued regarding the amount of dirt for the project. Mr. Gut stated that the amount of fill needed has been reduced due to the bridge option.

#### **ACTION ITEM:**

Agenda Bill #4039; A Resolution #15-010 adopting the Six-Year Transportation Improvement Program (TIP) for 2016-2021

**Summary:** Summary: The City is required by State law to annually review its TIP. This review is to include a PH and formal adoption of the program by the City Council. Revised Code of Washington (RCW) 35.77.010 requires the City to adopt a minimum Six Year TIP, prior to July 1 each year. The Growth Management Act (GMA), RCW 36.70A.070(6), requires the City to adopt a Comprehensive Plan (CP) transportation element that serves as a basis for the City's Six Year TIP. At this time, the funding distribution and scheduling of projects beyond the first two years is tentative. Further capital budgeting will be reviewed during next year's adoption of the City's 2017-2022 Capital Improvement Program (CIP).
