

Port Agreement Extension Adds to City Road Project Revenues

On December 22 the SeaTac City Council and Port of Seattle Commission adopted an amendment and extension to the 10-year interlocal agreement between the two organizations. In general, the amendment extends the agreement that expires February 16, 2016, to February 16, 2018.

Other amendments discontinue a set-aside of the commercial parking tax receipts previously reserved for constructing south access to the airport as well as funds dedicated to construction of two projects, one of which is completed. The total impact to City of SeaTac revenues is to retain 36.9% or approximately \$2.0 - 2.5 million in additional parking tax revenues annually for City transportation projects. Those projects do not require consultation with the Port of Seattle. However, the estimated \$3.2 million remaining in the set-aside for south access to the airport through the original term of the agreement would be expended only upon agreement by the City Council and Port of Seattle Commission.

Amendment #4 also extends agreement on Port payment of stormwater management fees for Seattle-Tacoma International Airport properties and removes Exhibit D regarding large trucking projects using City roads, as those provisions were adopted into the SeaTac Municipal Code in November.
