

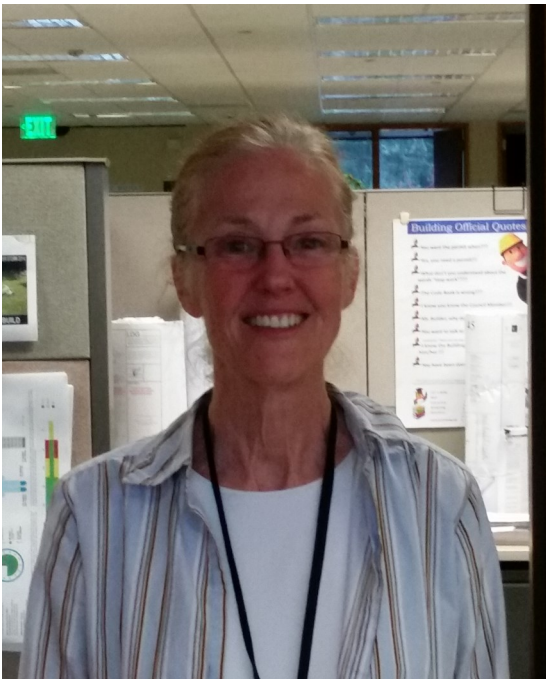
New Code Compliance Program Coordinator

Mary Kate comes to us out of retirement from the City of Spokane Valley where she was the Building Official supervising a staff of 11. She has been working as a technical consultant for the Washington Association of Building Officials focusing on the development of their new Code Official certificate program and supporting their Special Inspection Registration Program. Human Services Advisory Committee

- Meetings are held the third Monday of the month at 5:30 PM at SeaTac City Hall
- Make reports and recommendations on concerning human services issues
- Review City actions which may affect the accessibility or quality of human services available to the City's residents

Hotel/Motel Tax Advisory Committee

- Meetings are held the second Wednesday of the month at 3:00 PM at SeaTac City Hall
- Members represent the lodging industry or associated tourism-related enterprise, including not-for-profit organizations
- Provides insight on the City Council annual budget development and adoption process

Police News

Robbery - Suspect in Custody

On Friday February 19 at about 6:45 PM an adult male and female approached a female victim in the back lot of the Comfort Inn (S. 193rd Street/International Boulevard) as the victim placed items into her car. Although the male never physically touched the victim, he approached her so closely that she felt pinned to the door of the car, afraid to move. The female suspect grabbed the victim's purse from the front seat. They both ran away and were not immediately located.

At about an hour later, an alert patrol officer saw and arrested the female suspect on International Boulevard about a block from the where the robbery occurred. She admitted to stealing the purse and partially identified the male suspect who remains at large.

Shooting - Victim and Suspect Known to Each Other

In the early morning hours of February 23 SeaTac Officers responded to a home in the 4600 block of S. 170th Street, where an adult male had been shot by another adult male. The victim was transported to the hospital and is expected to survive. The suspect was at large until the afternoon of February 25, when he was taken into custody by Department of Corrections and KCSO Major Crimes Detectives.
