## **DESCRIPTION OF PROPOSAL:**

Amendments to SeaTac Municipal Code Chapter 15.700, Environmentally Sensitive Areas. Amendments include integrating the use of best available science in the contents of Critical Area Special Studies; new definitions including Qualified Professional in accordance with WAC 365-195-905; revising definitions as recommended by the Dept. of Ecology; a new section on Wetlands Identification and Rating; updates to Building Setbacks and Wetlands – Buffer Requirements; a revised framework for wetland mitigation, maintenance, and monitoring; and amendments to standards for Critical Aquifer Recharge Areas and Wellhead Protection Areas.
