Public Safety Training on Angle Lake	X Recommendation  Battalion Chief Peiguss explain the need of having watercrafts on Angle Lake was based on proximity to Fire Station #45 (they currently use Lake Washington at Gene Coulon Park in Renton). Maximum speed of the boats will be 20 mph which virtually eliminates a wake on the water. Training exercises will be conducted in the middle of the lake Will provide information and schedule to the Angle Lake Shore Club via their newsletter requesting to use the lake for training 2x per month. Offered alternatives: 1. Less than 2x per month; 2. Continue to use Lake Washington to conduct training but time will be a major concern. CM Kwon talked to several homeowners on the lake they didn't want any training performed on the lake due to the number of times requested and the wakes will be large. Wanted to be the voice of the homeowners and wanted to know the benefits of having training on the lake. DM Fernald asked how long it takes to get from FS #45 to Angle Lake, Asst. Chief Wiwel responded with 7-8 minutes. Boats are already hitched and ready

	to go if a call comes in. Lawrence mentioned that the fire fighters do some cross training with the lifeguards during the summer months.  Committee recommends taking item to City Council.
3. Urban Agriculture Code Amendments	X Recommendation  Kara Martin with Healthy Community Planning and Lindsey Fromme Hana and Dre Anderson with Forterra presented their roles in providing information to the community. Kate provided a packet detailing the code amendment information by reviewing the code and summary of the community engagement. Also presented overview of 1. Community Garden, 2. Market Gardens/Urban Farms, 3. Produce Stands/Famer's Market.  DM Fernald asked for the clarification of "urban farms" considered a loose term but can be categorized by farms for food, herbs, flowers, etc. CM Forschler suggested the code be kept as simple as possible. CM Kwon had questions about the questionnaire. City Manager Scorcio wanted to remind the committee that a questionnaire was conducted and not a survey.  Committee recommended the item go to City Council with no recommendation from the committee.
