CALL TO ORDER: The SeaTac City Council Regular Meeting was called to order by Mayor Michael Siefkes at 7:05 p.m.

COUNCIL PRESENT: Mayor Michael J. Siefkes, Deputy Mayor (DM) Pam Fernald, Councilmembers (CMs) Rick Forschler, Kathryn Campbell, Peter Kwon, Tony Anderson, and Erin Sitterley.

STAFF PRESENT: Acting City Manager Joe Scorcio, Senior Assistant City Attorney Mark Johnsen, City Clerk Kristina Gregg, Acting Community & Economic Development (CED) Director/Economic Development (ED) Manager Jeff Robinson, Senior Planner Anita Woodmass, Parks & Recreation (P&R) Director Lawrence Ellis, and Police Chief Lisa Mulligan.

FLAG SALUTE: Boy Scout Ian B. led the Council, audience, and staff in the Pledge of Allegiance.

PUBLIC COMMENTS: Karen Dove presented ANEW 2015/16 Outcomes.

Earl Gipson spoke regarding the employee code of ethics that was passed January 10, 2017.

Key City Issues Status

Acting City Manager Scorcio commented on the following:

- (1) process to clarify how items are referred to Council Committees. Council discussion ensued with consensus to keep the current process as it is for now;
- (2) 2016 Council Expenditure Report is on the website;
- (3) Council Expenditure Quarterly Reports will be posted to the website as prepared;
- (4) Firms Mobile Home Park relocation plan appeal comment period has been extended to January 26;
- (5) 42nd Avenue South at South 160th Street City is installing signage and working with neighbors on site issues, Tukwila has a road improvement project being completed this summer, SeaTac is working with them to improve the intersection;
- (6) user survey regarding City website upgrade is on the website and due by Monday, January 30;
- (7) February 1 The Reserve Ribbon Cutting;
- (8) February 1 Port of Seattle (POS) open house on tree removal program;
- (9) February 14 property settlement resolution will be presented at the Council Study Session (CSS) with proposed action at the Regular Council Meeting (RCM); and
- (10) employee making accusations against the city, staff can't speak regarding this issue as it is a current litigation.

CM Kwon requested regular updates on the status of Seattle City Light and Comcast refunds.

PUBLIC HEARING (PH) AND ACTION:

Vacating the right-of-way on South 190th Street from 32nd Avenue South to its western terminus. Mayor Siefkes opened the PH at 7:33 p.m.

City Engineer Cabudol reviewed the summary for Agenda Bill #4509.

CM Kwon questioned whether neighbors were notified. Mr. Cabudol stated notices were mailed to every resident on 32nd Avenue South.

There were no public comments.

Mayor Siefkes closed the PH at 7:35 p.m.

Agenda Bill #4509; An Ordinance #17-1005 vacating the right-of-way (ROW)on South 190th Street from 32nd Avenue South to its western terminus.

Summary: Huling Brothers Family, LLC. is planning to redevelop the properties adjacent to South 190th Street and will incorporate the proposed vacated ROW into their project. There are no future connectivity plans for this segment of ROW and it serves no apparent future municipal use.

The procedures for vacating a public ROW are set forth in the Revised Code of Washington (RCW) Chapter 35.79. The City Council set the date of the required PH for January 24, 2017 (Resolution #16-027) to consider the merits of the application to vacate the ROW in question. All utilities serving this area were given notice of the vacation request and this Ordinance reserves any existing utility easements in the vacated area until released by the grantee.

RCW 35.79.030 provides that the City may require compensation to the City for the acquired property, not to exceed the full appraised value of the area vacated. Therefore, the City will receive \$743,000 in compensation to the vacated area.

This item will be placed on the agenda for the January 24, 2017 Regular Council Meeting for a PH and subsequent Council action.

The vacation is conditioned on the Petitioner paying the cost of the full appraised value of the vacated ROW, in the amount of \$743,000.

CM Forschler: January 26 - LUP Committee meeting.

CM Kwon and Mayor Siefkes – Transportation & Public Works (T&PW) Committee meeting.

COUNCIL COMMENTS: CM Campbell urged residents to apply for the Neighborhood Sidewalk Committee which has three vacancies.

CM Kwon stated he is currently out of mailboxes but is developing a wait list.

CM Sitterley commented on the following: (1) condolences to family of shooting victim, and (2) challenged Council to find ways to make the City safer.

CM Anderson commented on the following: (1) agreed with CM Sitterley, (1) Valley Ridge fields was a good City investment; (2) appreciation of the Human Services Advisory Committee (HSAC), (3) appreciation of Pattie Lenz who hosted a fundraiser at Gregory's which raised approximately \$2,500 for the Holiday of Hope, and (4) SR509.

COUNCIL COMMENTS (continued): DM Fernald stated public safety is very important to her. She challenged residents to get involved and start more block watches.

Mayor Siefkes thanked staff working in the field for properly doing their jobs. He also echoed CM Anderson's comments regarding HSAC and DM Fernald's comments regarding violence. He requested Mr. Scorcio to review the budget and see if there are any savings to pay for an additional police officer.
