# City of SeaTac Regular Council Meeting Minutes

November 8, 2016 7:00PM

**CALL TO ORDER:** The SeaTac City Council Regular Meeting was called to order by Mayor Michael Siefkes at 7:02 p.m.

**COUNCIL PRESENT:** Mayor Michael J. Siefkes, Deputy Mayor (DM) Pam Fernald, Councilmembers (CMs) Rick Forschler, Kathryn Campbell, Peter Kwon, Tony Anderson, and Erin Sitterley.

## **Kev City Issues Status**

Acting City Manager Scorcio commented on the following: (1) An appeal has been filed by a resident of the Firs Mobile Home Park on the administrative decision regarding the closure plan. The appellant has until November 21 to submit additional information. The Hearing Examiner (HE) will review the appeal, which may occur the week of December 12; (2) Monday, November 21 – 4 p.m., Budget Workshop 5; (3) Senior Management Analyst was introduced during the Council Study Session (CSS) and final interviews are scheduled next week for the Management Analyst position; (4) Staff is still working with the Port of Seattle (POS) on reaching mutual resolution related to the city's appeal on the tree removal and flight safety program; (5) Recology Cleanscapes has updated their rate schedule for 2017 with an increase of \$1.11 per month (\$.91 is mandated by King County); and (6) Public Defender Services contract has an option for one year extension. He will be approving that contract but it's scheduled for a mandatory review.
