# City of SeaTac Special Council Meeting Minutes

April 25, 2017 5:00 PM City Hall Council Chambers

**CALL TO ORDER:** The SeaTac City Council Special Council Meeting (SCM) was called to order by Mayor Michael Siefkes at 5:00 p.m.

**COUNCIL PRESENT:** Mayor Michael J. Siefkes, Deputy Mayor (DM) Pam Fernald, Councilmembers (CMs) Rick Forschler, Kathryn Campbell *participated via telephone*, Peter Kwon, Tony Anderson, and Erin Sitterley.

**PUBLIC COMMENTS (related to the agenda items listed below):** Wendy Morgan gave the 2016 annual report for the Highline Botanical Garden

Velma Veloria, Andi Newman, Sylvia Aho, Amy Tower, and Lolita O'Donnell all spoke in support of the city becoming a Sanctuary City and in support of an Inclusivity Ordinance.

Earl Gipson commented regarding people making SeaTac safer, not a piece of paper.

Vicki Lockwood stated it was a compliment everyone taking their time to come out to speak regarding an inclusive ordinance, and stated it is the action of the people that makes a difference in making a city safe.

#### **AGENDA BILLS:**

Agenda Bill #4630; A Motion authorizing the City Manager to sign a new 5 year (2018-2022) Interlocal Agreement (ILA) for Animal Control Services with Regional Animal Services of King County (RASKC).

**Summary:** This proposed action provides Animal Control, sheltering, and licensing services that protects public Health and Safety and promotes animal welfare beginning January 1, 2018 and running through December 31, 2022.

The Council has handled the following matters over the last several months regarding Animal Control Services:

- November 21, 2016 recommended approval to send non-building Letter of Intent to contract with RASKC.
- January 12, 2017- Council was presented a decision timeline to continue services with RASKC.
- February 2, 2017- Public Safety and Justice (PS&J) Committee reviewed detailed information, alternatives and options and unanimously recommended to continue with RASKC.
- February 28, 2017- Agenda Bill 4560 was presented to Council with a motion authorizing the City Manager to negotiate a Final Agreement with RASKC.
- March 14, 2017- The Council approved Agenda Bill 4560, authorizing the City Manager to negotiate the Final Agreement with RASKC.

The 2018 Budget includes Expenditure of \$153,625 for RASKC.

PS&J Committee and staff recommend Council approve this motion.

Senior Management Analyst Ramsaur reviewed the agenda bill summary.

Agenda Bill #4631; A Motion authorizing the City Manager execute a contract with the Center for Advanced Transportation and Energy Solutions (CATES) to develop an Action Plan for bringing autonomous vehicles to

the City of SeaTac and reallocate \$20,000.00 within the Streets Fund, specifically from the 2017 Intelligent Transportation Systems Study, to pay for this work. The final scope of work shall be substantially similar to the scope provided in the attachment.

**Summary:** Following a Study Session presentation on March 14, 2017, the City Council directed the City Manager to identify possible funding that the Council could consider reallocating in the 2017 Budget to pay for this contract. Deferral of the Intelligent Transportation System (ITS) Study in the Public Works budget is the most viable option for funding.

In February of 2017, CATES submitted an unsolicited proposal to the City of SeaTac to prepare an Action Plan document with guidance for City of SeaTac to justify and act on bringing advanced transportation technologies that have the potential to reduce accidents, emissions and congestion to the City of SeaTac. An initial focus will be on the feasibility of automated mobility services that also have a significant economic development potential for the City.

The Action Plan would include a federal funding feasibility determination, with specific, immediately actionable grant opportunities identified for follow-on grant-writing and grant-submission action by the City if it were to decide to implement the Action Plan.

The focus of mobility services would be on SAE Level 5 (completely driverless), under 35 mph, multi-passenger, remotely monitored, street-legal, supplementary point-to-point transit within a specified operational design domain (ODD, as described by the U.S. Government). CATES has stated in its public presentations that the technology applications now exist that can be deployed within City of SeaTac inside of two years.

Funding for the proposed work would be addressed through the reallocation of 2017 ITS Study funds in the amount of \$20,000.00. This action will delay the start of work on the ITS Study until 2018.

This was a Council initiated request.

PW Director Appleton reviewed the agenda bill summary.

Council discussion ensued regarding including City's Information Technology infrastructure requirements and cost, and whether the Autonomy Vehicle Action Plan could be a part of the ITS Study which is already funded. Council requested seeing samples of CATES previous work.
