Name Our New Schools & Ask the Architects

Highline Public Schools Forms Naming Committees

Are you wondering how the new schools in Highline will be named and which students will attend? Here are some answers from Highline Public Schools and ways to get involved.



Help Name the New Schools in SeaTac and Des Moines

Highline is seeking members for two school naming committees. <u>Submit this online form</u> by September 29 to express interest in serving on one of the two committees:

- Naming Committee for the new middle school at the Glacier site (SeaTac)
- Naming Committee for the new elementary school at the Zenith site (Des Moines)

Each committee will represent various perspectives and stakeholders. The work of the committees will include community outreach and discussions that result in a list of three to five names to submit to the school board.

The school board will select the name of each new facility from the submitted lists. Schools in Highline must be named after people or geographic features, according to district policy.

Who Will Attend the New Schools?

When the new middle school opens in fall 2019, some students who are currently in fourth, fifth and sixth grades will be among the first set of sixth, seventh and eighth graders to attend the new school.

A citizen-led committee is working on recommendations for new middle school boundaries and adjustments to some elementary school boundaries necessary because of the new schools. Learn the timeline and process for determining who will attend the new schools starting in fall 2019.

Neighborhood Update

To help ensure safe takeoffs and landings, the Port of Seattle plans to remove and replant trees around Seattle-Tacoma International Airport.

These trees either are, or soon will be, tall enough to encroach upon the airport's airspace. Two Port-owned sites where removal and replanting will occur, are adjacent to homes along 15th Avenue S.

Removal work on the sites will start in late- September. Tree felling operations will begin on September 25 on the golf course and then move to south of S. 200th Street on September 26. We are anticipating that it will take approximately 3 weeks to complete the tree felling. Replanting is scheduled to take place October 2017 through March 2018.

Because it is an active construction zone, signage and fencing will be installed at both sites and an air horn will be used periodically for the safety of construction staff.

The contractor for P-4 and P-5 will be will be using the two blast air horn "all clear" protocol every time they plan on felling a tree. This is their signal to their own personnel that the area is clear and it is safe to fell the tree. Prior to felling trees, a sweep of the area will be done to ensure no non-essential personnel/public are in the area. The contractor will follow all applicable City of SeaTac noise ordinance regulations. The contractor's work hours will be approximately 7:00 AM to 4:00 PM.

Public Works Project Updates

2017 Overlay Project

The following roadways will be included in the 2017 overlay: 12th Place S. and 13th Avenue S. between S. 200th Street and S. 207th Street and S. 207th Street between 12th Place S. and 14th Avenue S. Highline Water District (HWD) will be replacing all of their water lines and services within the project limits. An ILA is being drawn up between the City and HWD to incorporate the water line replacement work into the 2017 Overlay project plans.

• 90% plans, specifications and estimate review have been completed. A meeting to discuss the review comments will be scheduled in October. Construction is planned for March/April 2018.

S. 168th Street Stormwater System Improvements

 A pre-construction conference was held on September 26. A notice to proceed will be issued on October 2 and construction will begin shortly thereafter. There will be some road closures during the construction work, with local access only.

ADA (American Disability Act) Transition Plan

 Data collection is ongoing. A data collection interactive portal has been established to monitor progress.

Permit Parking Program

• The first round of data acquisition is complete. A draft "Best Management Practices" document is in development. A public meeting was held on September 25.

Military Road and S. 152nd Street

Improvements for this road reconstruction and safety project include construction of buffered bike lanes; curb and gutter; sidewalks; new pavement; installation of street lighting; upgraded and interconnected signalization with pedestrian crossings; construction of a right turn lane on eastbound S. 152nd Street; and the elimination of the skewed intersection at Tukwila International Blvd. and Military Road S. This project is scheduled for construction in the summer of 2018.

- The draft geotechnical report has been submitted.
- A draft Stormwater Core Requirements Memo has been prepared.
- Project coordination meeting was held on September 21.
- 30% Plans are scheduled for delivery on October 16.



S. 166th Street Sidewalk Project

This Safe Routes to School Program grant funded project includes construction of sidewalks, curb and gutter, storm drainage facilities, installation of an enhanced crosswalk and radar speed feedback signs. This project is scheduled for construction in the summer of 2018.

- Work on NEPA permit is ongoing.
- Storm design requirements and predesign are underway.
- Public meeting is scheduled for October 25.

2018 Overlay Project

This project will reconstruct Military Road S. between S. 209th Street and the I-5 bridge. Work will include "rubbelization" of the existing concrete road in place and overlaying with hot mix asphalt, construction of storm water improvements, addition of pedestrian facilities and bicycle lanes, signal upgrades, roadway channelization, and permanent signing.

 KPG, Inc. has been selected to design this project. The City Council approved a motion to authorize entering into a professional services contract with KPG at the September 26 Regular Council Session.

S. 200th Street/26th Avenue Intersection Project

The scope of this project includes the grind and overlay of the intersection at S. 200th Street and 26th Avenue S., installation of ADA compliant sidewalks and ramps, pedestrian signal upgrades, signal loop detectors and channelization.

 The project was reviewed at the September 26 Council Study Session and was placed on the consent agenda for the October 10 Regular Council Session.
