The City was recognized by the nonprofit Arbor Day Foundation as a Tree City USA community for its commitment to urban forestry.

Mock Trial Exercises: Monday, June 14, Mr. Evin Shinn, along with his 7th grade class from Chinook Middle School, visited SeaTac Municipal Court to participate in Mock Trial exercises. The students performed incredibly well, while showing confidence and abilities beyond their years. Judge Cordi-Bejarano plans to work with Mr. Shinn to make this a regular program. She is also planning to visit his classroom in the upcoming school year to speak with the students about court proceedings, the legal process, and government in general.

Councilmembers and Staff Visit Tyee Campus: Recently, the three schools at the Tyee Educational Complex invited the City Council and staff to participate in their accreditation review process with the Northwest Association of Accredited Schools. Each school had a specific day dedicated to the accreditation. It involved spending a good portion of the day observing a typical day in the classroom(s), followed by assessment. Several City officials were able to attend. It was a great opportunity for us to interact with the students and staff on campus.

SeaTac Fire Captain Attends National Fire Academy: On Friday, June 4, Fire Captain Ed Johnson completed his week-long training in Fire Protection Systems for Emergency Operations at the National Fire Academy in Emmitsburg, Maryland. The course is designed to provide Incident Commanders (IC's) with an understanding of the fire protection features that are installed in buildings. Knowing how these systems work and their proper use will assist IC's to achieve strategic and tactical success. Topics addressed in the course included understanding the fundamental operations, strengths and limitations of built-in fire protection systems, including automatic sprinklers, standpipes, fire pumps, fire detection and alarm systems, smoke management systems, and special hazard fire protection equipment.

SeaTac Firefighters Union Local 2919 Fundraiser: The SeaTac Firefighters raised \$3,900 to benefit *Gloria's Angels* through their 8th annual charity golf tournament. *Gloria's Angels* mission is to seek to lift burdens and build communities so people can focus on caring for a family member with a life-threatening condition. The organization posted a special thank you on their website to SeaTac Firefighter Shawn Dailey for organizing the event.

American Cancer Society Highline Relay for Life: Team SeaTac participated in the *Highline Relay for Life* again this year. The Relay for Life held last weekend raises money for the American Cancer Society. Team SeaTac has raised \$1,300 and donations are still coming in.

Karate National Championship: The 49th American Amateur Karate Federation (AAKF) Traditional Karate National Championship was held at the SeaTac Community Center last week. The event started on Wednesday with the 1st AAKF National Camp, where athletes reviewed and increased their training and discipline for the martial art of Karate. On Friday, the tournament featured a Judges' Seminar. A Pacific Northwest Regional Shiai was held on Saturday morning and the National Championship Finals concluded Saturday afternoon. More than 50 athletes participated, representing eight out of eleven regions in the United States. Other representation included the head of the International Traditional Karate Federation and individuals from Canada, Mexico, and Venezuela. Athletes stayed at the Comfort Inn in SeaTac, which provided transportation to and from the community center and to local restaurants.


