

## Recology CleanScapes Holiday Services

### Holiday Tree Recycling

Recology CleanScapes will collect unflocked, undecorated, natural trees in lengths up to 4 feet. Customers who subscribe to food/yard waste collection service may place trees out for collection on their regularly scheduled food/yard waste collection day. Residential customers who do not subscribe to food/yard waste service may schedule collection of properly prepared trees during the first two full weeks in January at no additional charge. Contact customer service at 206.767.1166 or at [Seatac@recology.com](mailto:Seatac@recology.com) by Sunday, December 31 to schedule tree collection.

Flocked trees are **not accepted** in compost collection because flocking contains non-compostable materials including adhesives, flame retardant, or additives. Flocked trees may be disposed as garbage for an additional fee.

### Holiday Collection Schedule

Recology CleanScapes does not collect on Christmas or New Year's Day. This year, these holidays fall on a Monday. If your regularly scheduled service falls during this week, you will be serviced one day later. For example, Monday customers will be serviced on Tuesday, Tuesday customers will be serviced on Wednesday, Wednesday customers will be serviced on Thursday, and so on.

### Inclement Weather Issues

Winter storms could make it unsafe to collect customer containers. To find out about temporary service changes:

- If your services schedule is disrupted, Recology CleanScapes will collect your containers when it is safe to do so, typically on your next collection day.

## Results from Public Poll in Search for Next City Manager

During the month of October 2017, there was a non-scientific poll available for residents and business owners to give their input on key values, attributes and qualities sought in the next City Manager. The data provided by 62 individuals has been collected and reviewed. You can view the poll results [here](#).

The general results and comments will be used by the City Council as input into the job announcement when the recruitment for the position begins early in 2018. City Manager recruiting documents usually contain much more detailed information about the local community, operation of the local government and expectations of the City Manager than other staff positions. The more specific information that is provided in the announcement will help lead towards applicants more interested in our community rather than just in the job.

Examples include: community preferences about where the next City Manager should reside after hiring (such as in South King County) is important for potential candidates to understand. A community preference for someone who has experience working in public government agencies, or has applicable city manager or private executive management experience can encourage appropriately qualified candidates to apply. Reflecting desired qualities such as being an excellent problem solver, motivated to bring people together, establish goals and work thoughtfully with the City Council to achieve those city goals are important to know up front.

The poll provided the first of the opportunities for the SeaTac community to participate in this important decision facing the Council in 2018. The insight of the residents' and business owners' preferences for their next City Manager is valuable for this decision.

# Public Works Project Updates

## **South 168th Drainage Improvement Project**

Construction was recently completed on the South 168th Street Drainage Improvement Project. The project permanently reduced localized flooding near the intersection of S.168th Street and Military Road S. by lowering the conveyance system, allowing stormwater to flow eastward along the south side of S. 168th Street. Failing downstream culverts were replaced to ensure long-term performance and reduce erosion. The project was made possible with a \$90,000 Flood Reduction Grant from King County Flood Control District and \$144,000 from the SeaTac Surface Water Management Utility.

## **Highline Water District Repair Work – S. 176th Street**

Water main repair work by Highline Water District (HWD) is ongoing along S. 176th Street, between Military Road S. and 42nd Avenue S. Traffic is being managed through a single lane closure during construction. ## **Level 3 Utility Work – Military Road S.**

Fiber optic installation work by Level 3 was scheduled to start Friday, December 1 along a route that begins at International Blvd at S 152nd Street and ends at Military Road S and S 228th Street. The work is scheduled to be performed at night and will involve accessing existing manholes in the roadway to install new fiber optic cable. Appropriate traffic control measures and off-duty officers (as required) will be implemented to manage traffic through this work area.

## **Utility Work – South 188<sup>th</sup> Street**

Utility work for the Hilton Garden Hotel (currently under construction) at 3056 S. 188th Street will begin soon. This work will require lane closures in S. 188th Street east of International Boulevard. Several utilities will need to be installed across S. 188th Street to serve the new hotel. Appropriate notification, traffic control measures, and off-duty officers (as required) will be implemented to manage traffic through this work area. No lane closures will be allowed in the week before Christmas.

## **12th Place and 13th Avenue S. Overlay Project**

The scope of this project includes pavement repair, asphalt paving and stormwater improvements on 12th Place S. and 13th Avenue S. between S. 200th Street and S. 207th Street and S. 207th Street between 12th Place S. and 14th Avenue S. Highline Water District (HWD) will be replacing all of their water lines and services within the project limits.

- 100% plans, specifications and estimate are being prepared
- Construction is planned for March/April 2018

## **ADA (American Disability Act) Sidewalk Transition Plan**

- Data collection is complete and the draft plan is being developed
- A public meeting is scheduled on February 1, 6:00 PM in the Council Chambers

## **Permit Parking Program**

- Review of draft "Best Management Practices" document and matrix of proposed treatments is complete
- Draft to be brought to Public Safety and Justice Committee in January

### **Military Road and S. 152nd Street**

Improvements for this road reconstruction and safety project include construction of buffered bike lanes; curb and gutter; sidewalks; new pavement; installation of street lighting; upgraded and interconnected signalization with pedestrian crossings; construction of a right turn lane on eastbound S. 152nd Street; and the elimination of the skewed intersection at Tukwila International Blvd. and Military Road S. This project is scheduled for construction in the summer of 2018.

- Continued preparation of figures for property owner outreach
- Development 60% plans is underway

### **S. 166th Street Sidewalk Project**

This Safe Routes to School Program grant funded project includes construction of sidewalks, curb and gutter, storm drainage facilities, installation of an enhanced crosswalk and radar speed feedback signs. This project is scheduled for construction in the summer of 2018.

- Draft NEPA documentation is complete and under review
- Utility coordination is underway
- 60% design is underway

### **2018 Overlay Project**

This project will reconstruct Military Road S. between S. 209th Street and the I-5 bridge. Work will include “rubbelization” of the existing concrete road in place and overlaying with hot mix asphalt, construction of storm water improvements, addition of pedestrian facilities and bicycle lanes, signal upgrades, roadway channelization, and permanent signing.

- Project coordination meeting held on December 13
- Geotechnical work continues
- Traffic count completed

### **S. 200th Street/26th Avenue Intersection Project**

The scope of this project includes the grind and overlay of the intersection at S. 200th Street and 26th Avenue S., installation of ADA compliant sidewalks and ramps, pedestrian signal upgrades, signal loop detectors and channelization.

- A project kickoff meeting occurred on November 14
- Preliminary design has begun

### **Pavement Condition Survey**

IMS Infrastructure Management Services LLC has been conducting a detailed inventory and condition rating of all city streets between October 16 and November 24. Data collection is complete and a draft report is being prepared.

### **35th Avenue South/37th Place South Safety Improvement Project**

- Three alternatives complete
- Presentation to T&PW Committee on December 21

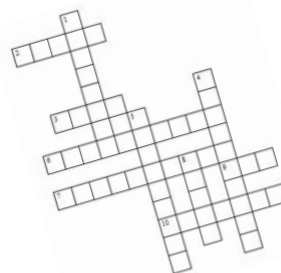

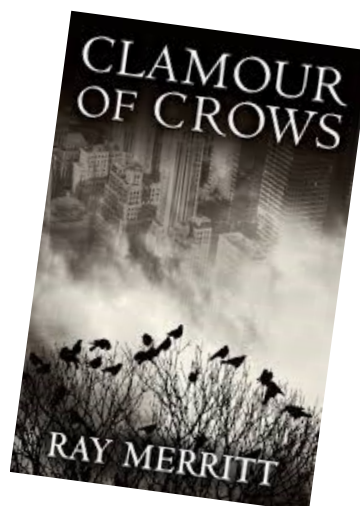
