Transportation Concurrency (Transpo Group)	Patrick Lynch of TranspoGroup presented a Concurrency Program Update, describing what a concurrency program is and what are the various metrics for measuring a successful concurrency program. The City could measure simple corridor-level intersection delay, arterial travel time/speed, system completeness or a hybrid of some type. Councilmember Forschler asked if we could use INRIX data to inform some of the data needed for our concurrency program, and also enquired about how this work might tie in with how we determine SWM fees in the future. 6.	Regional Transportation Initiative	King County has started a new Regional Transportation System Initiative on the premise that the regional's transportation systems benefit all cities within King County and all travelers. Countywide there are many infrastructure improvements and maintenance requirements needed in upcoming years to a total of about \$19 Billion. To meet this need, King County is proposing a number of taxes and other proposed new revenue sources. There will be a meeting of jurisdictions at a regional transportation meeting on January 5 th to discuss and gauge support for this initiative.	Committee is considering not supporting the Initiative based on discussion. The committee was unanimously opposed to burdening SeaTac residents with additional taxes to pay for this program. The committee supported the mayor communicating this message during the next RTSI Executive meeting on January 5.	15
