CALL TO ORDER: The SeaTac City Council Regular Meeting was called to order by Mayor Mia Gregerson at 6:30 p.m.

COUNCIL PRESENT: Mayor Mia Gregerson, Deputy Mayor (DM) Anthony (Tony) Anderson, Councilmembers (CMs) Barry Ladenburg, Kathryn Campbell, Terry Anderson, Dave Bush, and Pam Fernald.

STAFF PRESENT: City Manager Todd Cutts, City Attorney Mary Mirante Bartolo, City Clerk Kristina Gregg, Assistant City Manager (ACM)/Acting Public Works (PW) Director Gwen Voelpel, Community & Economic Development (CED) Director Joe Scorcio, and Economic Development (ED) Manager Jeff Robinson.

FLAG SALUTE: Mayor Gregerson led the Council, audience, and staff in the Pledge of Allegiance.

PUBLIC COMMENTS: Greg Horn and Pat Jorgenson spoke regarding the limo parking and natural gas station in the Sue Linda neighborhood. They stated their appreciation of the City looking into their concerns.

Vicki Lockwood stated her opinion that the current Council is "nickel and diming" the residents.

Doris Moe spoke again about the house at 3204 South 173rd Street. She stated Code Enforcement is unable to help due to resources and code strength and the King County Health Department says it is not at the point it can be declared a health hazard.

Joel Wachtel questioned whether the Council has a comprehensive plan to deal with crime and whether it is included in the budget with the utility tax increase.

Lois Slade spoke regarding Limos parking in the Sue Linda neighborhood and the natural gas station. She questioned when the traffic study will be done.

Steve Pinto requested a meeting be held during an election year for residents to ask questions of the candidates.
