



City Manager's Weekly Update

September 17, 2010

Dear Mayor, Councilmembers, Residents, and Employees:

Mayor and Interim City Manager Tour King County Executive: Recently, Mayor Terry Anderson and Interim City Manager Todd Cutts gave King County Executive Dow Constantine a tour of the City. The tour included stops at the SeaTac/Airport Light Rail Station, the 154th Street light rail station redevelopment area, the Riverton Heights site, Consolidated Rental Car Facility, and potential FAA locations, among others. Other topics discussed included contracted police and animal control services, the City budget, SR 509, and human services. The goal of the tour was to provide the Executive with SeaTac's perspective as he makes difficult decisions regarding the County budget and other matters.

SeaTac BMX Event: The North SeaTac Park BMX Club hosted the 2010 Washington State Championship finals event on September 11 and 12 at the North SeaTac Park BMX track. There were over 400 riders on both days and a large turnout of spectators. Everyone had a great time and the event ended without injury.

Miller/Walker Creeks Stewardship Volunteer Opportunity: How many adult salmon return to Miller and Walker Creeks in Burien, Normandy Park, and SeaTac each year? The fact is we have only a general idea. In addition, we don't know how many of these fish are stricken by pre-spawn mortality and thus how many are surviving long enough to lay the eggs of the next generation. Knowing adult salmon numbers and what's happening to them once they enter the stream will serve as "vital signs" for our streams.

To accurately monitor adult fish returns and fish health, the Miller/Walker Creek Stewardship needs your help! Volunteers are needed to collect data on adult salmon that will return to Miller and Walker Creeks from mid-October to late December. This is an exciting and unusual opportunity to see parts of your community that are normally inaccessible. You will get closer to one of the iconic animals of America – the Pacific salmon. You will be part of an important community effort to better understand how well the Stewardship is doing taking care of our lands and waters. Volunteers are asked to please sign up by Tuesday, September 28.

Fire Responds to Serious Accidents: On September 10, at approximately 1:00 AM, SeaTac Fire responded to a motor vehicle accident at the 19400 block of Des Moines Memorial Drive. The vehicle had partially sheared a telephone pole and was upside down, with two people

trapped. Both patients were transported to Harborview Medical Center by Medic One, assisted by Fire Department personnel. SeaTac Police are investigating the accident.

On September 10, at approximately 2:20 PM, SeaTac Fire responded to a car/motorcycle accident on southbound I-5 near the 200th Street off-ramp. A motorcycle had rear-ended a vehicle. The rider, a 59 year old man, while he was wearing a helmet, suffered serious head injuries. Crews provided emergency medical care, quickly stabilized the patient, and transferred him to the Medic One crew, who then transported him to Harborview Medical Center. Washington State Patrol is investigating the accident.
