2. Scope & Schedule	<p><u>X</u> <u>Informational Presentation. Committee will decide on the breadth of the sidewalk program (do we want to include more than just residential neighborhoods?) and develop a schedule for staff to work from</u></p> <p>Public Works Director Will Appleton discussed that the group would be choosing which elements the Committee wants to see in the sidewalk selections.(such as: sidewalks only or complete streets, traffic calming elements, one size fits all throughout the city or site specific design). The group was informed of the long term funding made available to the City to install sidewalks. Project design \$250,000 Project construction \$1.5 Million Each year a project would be in design and the previous year's design would be under construction.</p> <p>The group was also informed of the need for the group to decide at the next meeting if they would use current scoring criteria to choose a project to design for 2018, or create new criteria and wait for a first project in 2019 from the new criteria.</p> <p>Deputy Mayor Fernald asked for Traffic Calming information be sent to all Committee members by email soon as part of their homework before the next meeting.</p>

ADA Transition Plan</p>	<p>X__ Discussion of the ADA Transition Plan and how it plays into our sidewalk planning and construction.</p> <p>City Engineer Florendo Cabudol presented the City's plan to perform a self-evaluation of barriers to access for individuals with disabilities, and the ADA Transition Plan that will be created as part of this effort. He explained how having this plan in place would help inform the Neighborhood Sidewalk Committee of various retrofits that could be made to adjacent locations as part of sidewalk construction efforts.</p>

Sidewalk Project Selection Criteria</p>	<p>Public Works Director Will Appleton asked the group to review the current project selection criteria as homework before the next Neighborhood Sidewalk Committee meeting, and to consider what changes or adjustments to the criteria they would like to see made based on the ideas presented at the meeting.</p> <p>Chair Campbell asked the group to travel to a different area of the City than they normally go to, and envision what sidewalks would look like, how it might impact pedestrians in that neighborhood, as homework.</p>
