1. Call to Order	Chair Fernald called the meeting to order at 6:00PM
2. Public Comment	<p>Vicki Lockwood had several questions regarding the Permit Parking Program Ordinance in regards to Commercial Vehicles and trailers connected to trucks. She also expressed a concern with wording in 9.50.090 section A.2.g saying that it appears that the City would have the authority to force residents to use alternative modes of transportation.</p> <p>Kris Jaspers asked if the car obtaining a permit had to be registered to that house and was concerned with renters. She also asked if 'for-hire' vehicles will receive tickets.</p>
3. Review of 9/13/18 Minutes	<p><u>X</u> Approval</p> <p>Committee approved the meeting minutes as written.</p>
4. SCORE	<p><u>X</u> Update – Tim Ramsaur and Chief Carl Cole gave an update on the ILA between the City of SeaTac and SCORE to include SCORE services, programs and community collaboration. City of Federal Way sent a letter to SCORE expressing an interest in opting out of membership due to high costs, which prompted the City of review the ILA.</p> <p>Background: The City of SeaTac along with Federal Way, Tukwila, Renton, Auburn, Des Moines, and Burien entered into a partnership to have SCORE as their misdemeanor jail because King County stated that they would no longer accept any misdemeanor bookings. The original agreement was to have the member cities pay a lower cost for use of the facility than the contract cities, however, rising costs and the way SCORE allocates fees such as Alcohol, Benzodiazapine and Opiate Withdrawal Protocols made it higher for member cities than contract cities. Yakima is also able to offer similar services, including transport, at a lower cost than SCORE. The intent is for Tim Ramsaur and Carl Cole to review the ILA and update so that member cities pay the same rates and contract cities pay more than member cities.</p>

5. Permit Parking Program	<p><u>X</u> Direction – Chief Carl Cole and Cindy Corsilles presented the draft of the Permit Parking Ordinance 9.50 for committee approval. This Ordinance establishes parking zones and the ability to enforce them. This pilot program was created to establish rules and regulations and prioritize parking for residents and manage availability of on-street parking in residential areas. The Ordinance defines authority of City staff, permit types, application, fees, issuance, expiration and renewal, appeal process, restrictions and neighborhoods, and enforcement and violations. Concern was brought up regarding 9.50.090 Establishing, Expanding and Reducing Permit Parking Zones, item A.2.g; Promoting the use of alternative modes of transportation.</p> <p>Discuss / Questions followed.</p> <p>Committee recommends Ordinance go to Council with removal of 9.50.090 section A.2.g.</p>
6. Port of Seattle Crime Stats	<p><u>X</u> Update – Chief Carl Cole explained that the Port of Seattle reports separately to the FBI and does not divide out crime stats from incidents occurring at the airport from their other jurisdictions. Chief Cole will request a breakdown of crime stats of incidents occurring at the airport from the Port of Seattle and update the committee at a future meeting.</p>
7. Future Meeting Topics	<p>Committee would like an overview of Parking Compliance, mail theft updates, CPTED overview and general information, Trespass Ordinance, and allow referrals from staff to go to a Council Committee.</p>
