New Chair and Member	CM Wachtel new chair. Mayor Sitterley stated that former chair Mike Siefkes has moved out of state. She appointed Councilmember Wachtel as the chair and will be appointing another councilmember to the committee shortly.
Approval of the Minutes	The minutes from the last meeting dated 7/16/18 were approved as written.
Nov 5 Volunteer Appreciation Lunch	Exec. Asst. Ellis reminded the committee of the invitation and asked for RSVP's.
SAMP Scoping Comments	<p>Clare Gallagher provided statistics and an overview of the process.</p> <p>Over 300 attendees according to sign-in sheets from the open houses; 5,000 page hits online open house; over 3000 viewed; received multiple comments with an estimate of about 750 comments.</p> <p>Port & FAA reviewing all comments; will prepare a response in early 2019. Will report out to Port Commission and mail out to parties. Environmental review documents in late 2019.</p> <p>Steve Pilcher reviewed the City's comments and those of the four cities. Highlighted concern about breaking the analysis into pieces. Will email out background report to committee members.</p> <p>Discussed SASA: Project not dead, but not being analyzed in this current proposal.</p> <p>Airport Advisory Committee members commented that noise impacts in the area along 12th Ave. S need to be addressed as well as health impacts from increasing air traffic and fumes, as well as vehicle access concerns with growth in TNC and taxis.</p> <p>Committee member requested by Ms. Gallagher provide TNC report.</p>
Aviation Noise/ Emissions Symposium	Mr. Scorcio noted that the materials were sent to the Committee. The City is considering identifying both staff and others to attend. Mike Siefkes and Steve Pilcher attended last year. This year's dates and location are March 4-6, 2019 in Jacksonville, FL
Port's StART Committee	Mr. Scorcio and Ms. Gallagher discussed some of the issues interfering with the effectiveness of the Committee created as an advisory committee to Aviation Director Lance Lyttle. There was acknowledgement that the public may have seen this as an avenue for venting frustrations but it has become disruptive to the effectiveness of the StART Committee whose makeup includes city officials, community representatives, FAA, airlines, and transportation at the table looking to work together constructively to find solutions. A subcommittee is specifically looking into noise issues and possible mitigation strategies. The next meeting is October 24.

<p>Department of Commerce's Sea-Tac International Airport Study Advisory Committee (SSAC)</p>	<p>Mr. Scorcio reported that the City worked with the legislature to study existing impacts and conditions of the airport. The study is funded ½ by the State, and matching funds from the cities of SeaTac, Burien, Des Moines, Federal Way, Normandy Park, and Tukwila. Department of Commerce delayed the start of study to restructure the format for representatives from the public. The City Council appointed Roger Kadeg as our citizen representative to the Washington State Department of Commerce Sea-Tac Airport Study Advisory Committee (SSAC), and he attended the first meeting earlier today.</p> <p>The Department of Commerce Sea-Tac Airport Impact Study will study data on both the impacts and the benefits of the airport.</p> <p>He added that a parallel study is being conducted by the UW in regard to ultrafine particulates; Councilmember Kwon is involved in that study.</p>
