

State Route 99/Alaskan Way Viaduct Closure Information



This is a reminder that SR 99 closes permanently tonight at 10:00 PM

The "Realign99" closure sequence is as follows:

- 10:00 PM on Friday, January 11: Full SR 99 Closure Through Downtown Seattle Begins
 - SR 99 closes both directions from South Spokane Street to the south end of the Battery Street Tunnel.
 - Battery Street Tunnel remains open with one lane in each direction. Ramps to and from Western Avenue remain open.
 - West Seattle Bridge and off-ramps to First Avenue and Fourth Avenue remain open and do not close as part of Realign99.
- 10:00 PM on Friday, February 1: Battery Street Tunnel Closes
 - Battery Street Tunnel closes. On-ramp and off-ramp from Battery Street Tunnel to Western Avenue also close.
- Early February (exact date TBD): New Tunnel Opens
 - SR 99 reopens about three weeks after January 11, with highway using new SR 99 tunnel. Alaskan Way Viaduct and Battery Street Tunnel remain closed. One SR 99 off-ramp remains closed (see below).
- Approximately Two Weeks Later: Final Ramp Opens
 - New SR 99 northbound off-ramp to downtown and Alaskan Way (just south of tunnel) opens, about two weeks after SR 99 tunnel opens.

Join Sea-Tac Airport and community members to get muddy as we plant native trees at the Miller Creek Community Planting site on the morning of Saturday, January 26. Participants will plant 180 trees at a site previously overtaken by invasive blackberry and ivy. The trees planted will increase native forest cover and convert understory from invasive blackberry to native vegetation.

The planting event is part of the Port of Seattle's restoration of airport lands and an opportunity to engage with other community members invested in urban forests and land stewardship.

Alternative Transportation Options During 99/Alaskan Way Closure



As people face regional traffic woes across Puget Sound, King County Metro is launching services to help keep people moving. Residents in Normandy Park and portions of Burien, SeaTac, and Des Moines will soon have a new and easy way to get around using Normandy Park Community Ride, a reservation-based service that launched on December 17.

Normandy Park Community Ride travels within a specified service area, instead of along a fixed route and is offered by King County Metro as part of the Community Connections Program, operating under contract by Hopelink.

Riders can reserve rides anywhere throughout the City of Normandy Park, and portions of SeaTac, Burien, and Des Moines. The service provides midday transportation from 10:00 AM to 4:00 PM on Mondays, Wednesdays, and Fridays, and 11:00 AM to 3:00 PM on Saturdays.

Signed locations for riders to board and exit the Normandy Park Community Ride vehicle are provided at the Burien Transit Center, Angle Lake Station, and designated neighborhood transportation hubs at City Hall Park and Marvista Park in Normandy Park.



Public Works Project Locations





Restoration Work - South 188th Street

Preparation is ongoing to restore pavement, curbs, gutters, and sidewalks in front of the new Hilton Garden Hotel (currently under construction) at 3056 South 188th Street. The restoration work will require lane closures on South 188th Street east of International Boulevard. Appropriate notifications, traffic control measures, and off-duty officers (as required) are being used to manage traffic through this work area.

South 200th Street Shared Use Path

This project includes building a new separated shared use path along South 200th Street between 12th Place South and the Des Moines Creek Trailhead. The Project will provide pedestrian connections to street improvements that will be constructed at the intersection of Des Moines Memorial Drive South and South 200th Street, and a connection to existing pedestrian and bicycle facilities accessing the Angle Lake Light Rail Station.

South 166th Street "Safe Routes to School" Project

This "Safe Routes to School" grant-funded project includes construction of sidewalks, curbs and gutters, storm drainage facilities, installation of an enhanced crosswalk, pedestrian lighting, and radar speed feedback signs. Construction has begun.

Military Road South and South 152nd Street

Improvements for this road reconstruction and safety project include construction of bike lanes, curbs and gutters, sidewalks, new pavement, installation of street lighting, upgraded and interconnected signalization with pedestrian crossings, construction of a right turn lane on Eastbound South 152nd Street, and the elimination of the skewed intersection at Tukwila International Boulevard and Military Road South.

Private Development


Expect traffic impacts and lane closures on northbound International Boulevard at South 173rd Street as work continues on the Hyatt Place Hotel.

Traffic impacts are continuing on 29th Avenue South at the Vintage Retirement Homes construction project.

Midway Sewer will start a sewer main extension for the Des Moines Creek North Business Park on Monday, January 14, that will close the southbound lanes on 24th Avenue South at South 208th, with the northbound lanes being converted into a split-directional roadway. The work is scheduled to take two to three days.

Two new projects; the Copper River Development, and the Wingate Hotel on Southbound International Boulevard near South 190th Street, are expected to have minimal traffic impacts.


2019 Comprehensive Plan and Development Regulations Amendment Process Underway



The Comprehensive Plan presents the community's vision for how the city should grow and change to meet the demands of a growing region. This biennial amendment process (occurring in odd-numbered years) is an opportunity for community members to propose changes to the Comprehensive Plan. Additionally, in order to maintain consistency between SeaTac's development regulations and the Comprehensive Plan's goals and policies, the City is conducting a concurrent development regulations amendment process.

Information and amendment application packets are available from the Department of Community and Economic Development, or via the Comprehensive Plan web <u>page</u>. The submittal deadline for Comprehensive Plan and Development Regulations amendment applications is Friday, March 29, 2019.
