1. Call to Order	Chair Fernald called the meeting to order at 6:00PM
2. Public Comment	There were no public comments.
3. Review of 1/10/19 Minutes	<u>X</u> Approval
	Committee approved the meeting minutes as written.
4. Fire Code Amendments	 X Discussion – John Napier/Fire Marshall, presented to the Committee Agenda Bill #5139, which is an Ordinance amending Sections 13.150.060 through 13.150.090 of the SeaTac Municipal Code related to submission of records to the Fire Code Official. This Ordinance clarifies that the Fire Code Official may dictate the forms and manner of the submissions of the testing and inspection reports. Puget Sound Regional Fire Authority recently began using a third-party inspection software called The Compliance Engine, which will eliminate all paper processes, filing, scanning and imaging of documents. The software will also provide a function of tracking each of the systems and their compliance with the codes and standards adopted by the City. There is no budget significance. Discussion / Questions followed. Mayor has authorized placing this item directly on the Council agenda.
5. BERK Study Prelim Final Results	X Presentation –Tim Ramsaur and BERK Consulting gave a presentation on the preliminary final results of the BERK Study for the City's ILA for police services with King County Sheriff's Office. This study looked at the community characteristics with an increase in ethnically diverse population with a decrease in the population speaking English, the challenges of lags in hiring desired staff with efforts to increase the diversity of the force, the increase in the use of

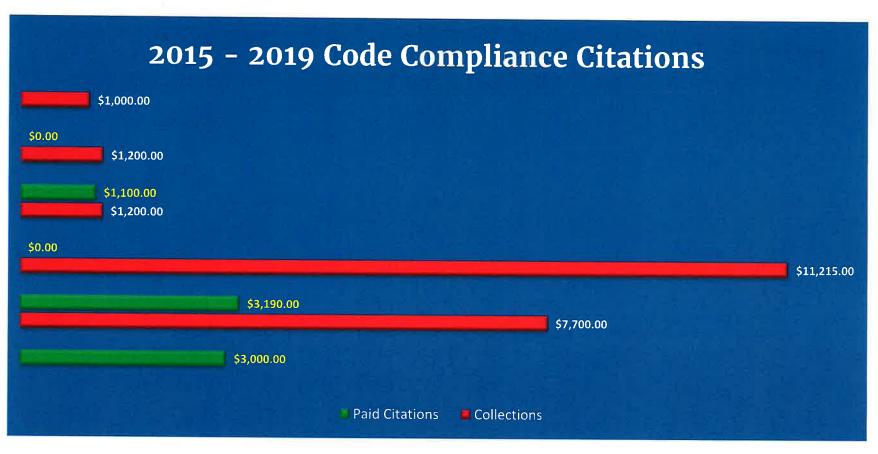
	transit (airport and light rail), service challenges for providing service which are expanding expectations for the roles of police and volume in calls for service, and the trends in crime and calls for service with an increase in DCFS. BERK presented to the Committee a list of recommendations which were ranked in priority from low to high. Discussion / Questions followed.
	Committee would like to present this to Council Workshop on March 29, 2019. Pam would also like to get feedback from the community on what their priorities are vs what Police thinks the priority should be. Item to be brought back to PS&J.
6. Permit Parking Program	X_Update – Jon Mattsen gave an update on the status of the Permit Parking Program. Projected start date is March 15, 2019. Signs are being posted in the neighborhoods, the Parking Compliance vehicle has equipment installed except for the plate reader which will be done on February 24, 2019. The PPO radios have been ordered, uniforms have been chosen, and the patches are in the works. Staff is currently working with Washington State Courts (AOC) on vendors and processes for infractions. Of the two positions hired, one was disqualified during KCSO background checks. The City will post the position again. One current issue is Legislation has introduced a House Bill that will limit the use of plate readers. Kyle Moore went to Olympia today to lobby this issue. Jon said there will be some growing pains with the program and will need community feedback. Discussion / Questions followed.

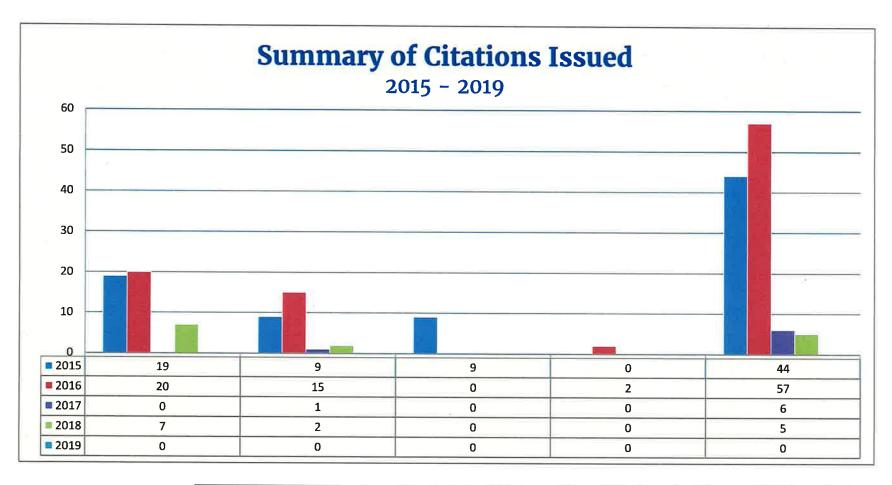

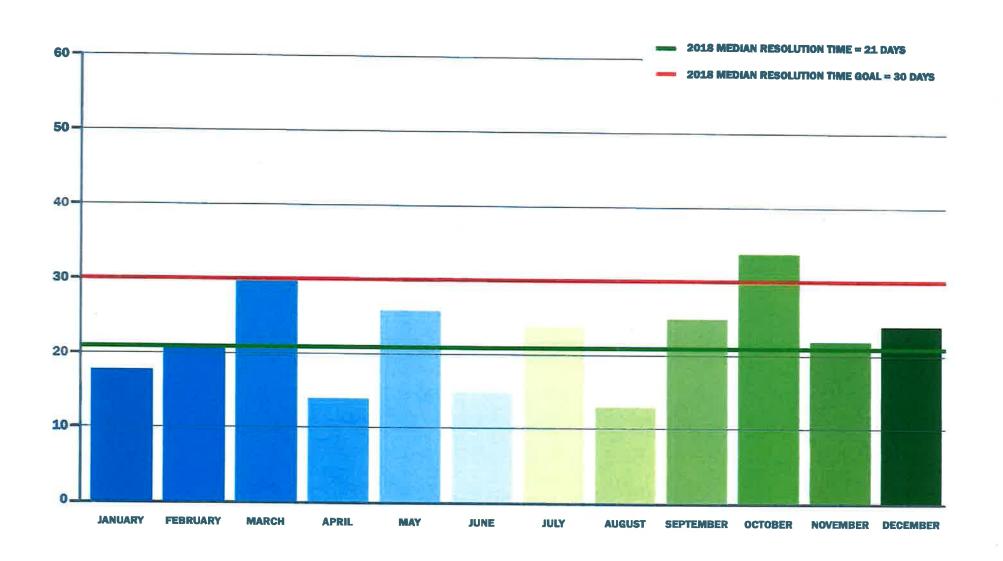

Median time to resolve code compliance cases

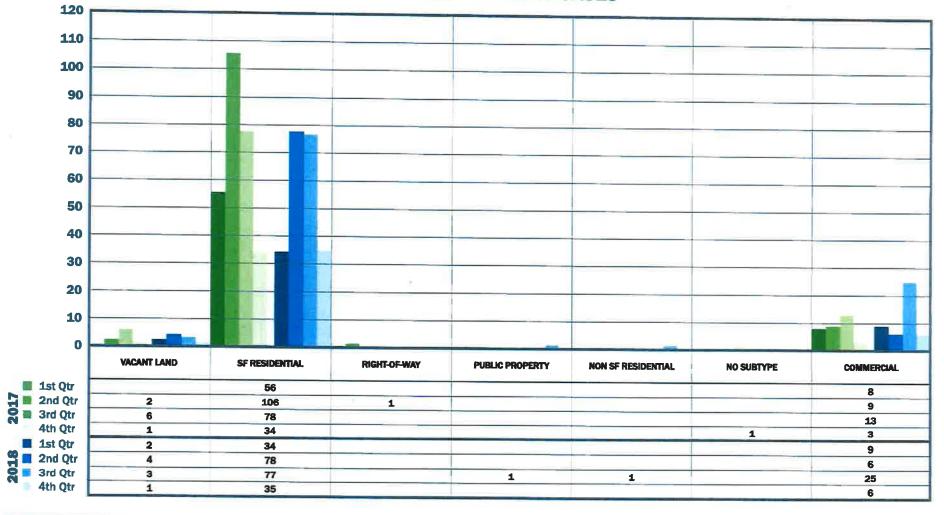


CODE COMPLIANCE CASES OPENED
