1. Call to Order	Chair Fernald called the meeting to order at 6:01PM
2. Public Comment	There were no public comments.
3. Review of 1/10/19 Minutes	<u>X</u> Approval Committee approved the meeting minutes as written.
4. Red Light Discussion	<u>X</u> Discussion – Chair Pam Fernald wanted discussion on whether to bring back the red light cameras at select intersections in SeaTac. Tim Ramsaur gave a brief history: red light cameras were placed at the intersections of S 188 th St / Int'l Blvd, S 188 th St / Military Rd S, S and 200 th St / Int'l Blvd. Statistics showed that 90% of the red light citations were issued to non-residents and 10% issued to residents. Jon Mattsen gave some statistics on collision records at these intersections. At two locations, 200 th St / IB and 188 th / MRS, the number of collisions since the removal of red light cameras have gone down. At 188 th / IB, collisions have gone up. There was discussion of putting a camera in the school zones to capture speeding that uses the same mechanism as a red light camera. Committee wants additional information, Jon Mattsen explained the data set will be difficult to obtain and will look at what needs to be done and the cost. Discussion / Questions followed. Committee would like additional stats on volume of traffic and total accident data for further discussion.
5. Code Compliance	<u>X</u> Discussion – Steve Pilcher distributed a brief history of the Code Compliance Committee and the topics they discussed. The purpose was to consider matters related to code compliance issues and priorities and to forward

	<p>recommendations to Council for action. The committee was disbanded in April 2018 but is now being included in the PS&J Committee. Currently there are 67 cases open in 2019, up from 40 in 2018. Staff currently operates on a reactive process rather than proactive. Issues are: some people don't cooperate with City, timeframe for letters and citations to give residents opportunity to comply is long, and even if they are cited as a criminal misdemeanor it's lengthy and costly to go through a court abatement process. Jon Mattsen stated that police and Community Service Officers work together with Code Compliance and will continue to do so. Steve is seeking guidance on what Committee wants as far as reactive /proactive measures, length of process to correct violations, and how hard does the committee want staff to push residents to comply.</p> <p>Discussion / Questions followed.</p> <p>Committee would like list of priorities for code compliance and regular updates.</p>
6. Elder Abuse / L.E. Protocols	<p><u>X</u> Update – Tim Ramsaur and Kim Cooper met with the Fire Department regarding potential vulnerable adults in SeaTac. Kim has taken the lead on this as it falls under Human Services. A question was asked on whether the City can tie into services already provided by the Aging and Disability Services for Seattle and King County to provide needs and assessments.</p> <p>Discussion / Questions followed.</p> <p>Committee to table for future meeting.</p>
