August 13, 2019 6:00 PM City Hall Council Chambers

CALL TO ORDER: Mayor Erin Sitterley called the SeaTac City Council Regular Meeting to order at 6:00 p.m.

PUBLIC COMMENTS: Richard Gerlitz stated he is concerned with the erosion of his property line where new construction is being built without provision for a bulkhead,

Rose Clark, Des Moines Memorial Drive Preservation Association President, provided history and an update on the association purpose. Requested to come back with presentation.

Earl Gipson spoke regarding the Legislative Update, stating the State legislature needs to stay out of local politics.

ACTION ITEMS:

Agenda Bill #5242; A Motion authorizing the City Manager to execute a contractwith Bruce Dees and Associates LLC for design and construction management for installation of synthetic turf on the two existing soccer fields located in North SeaTac Park.

Summary: Bruce Dees and Associates LLC will design and provide specifications for the synthetic turf installation and retro-fitting of the lighting system on the two existing sand based soccer fields in North SeaTac Park. The scope of services will include schematic design, design development, preparation of construction documents, bidding, construction review and project oversight. The existing fields are sand based that were constructed in 1994, and they have been severely underutilized during the past 10+ years due to the poor quality of the fields. In fact, there have been no scheduled activities on these fields since 2013.

The main elements of this project will include the installation of synthetic turf (similar to the synthetic turf recently installed at Valley Ridge Park [VRP]) and retro-fitting the lighting system by upgrading to LED lighting. The renovation of the soccer fields will generate significant revenue through the number of field rentals and tournaments. With these improvements, the two fields should generate a minimum of \$750,000 in the first five full years of operation.

After review of architect qualifications through the MRSC Architectural and Engineering Roster, Bruce Dees and Associates LLC was determined to be the most qualified to perform this work. The cost of this contract will not exceed \$205,215. This fee was negotiated and is based on the Washington State Architecture and Engineering fee schedule that bases the design fee on the estimated construction cost of the project.

Once this project has been designed, the project will be formally bid, and the Council will be asked to award the construction contract to the lowest responsible bidder.

The project was approved as part of the 2019-2024 Capital Improvement Program (CIP) in the 2019-2020 Biennial Budget. The projected budget of \$2,077,093 is funded through Asset Sales, Real Estate Excise Tax and Construction Sales Tax revenues in Fund #301. The cost of this contract will not exceed \$205,215.

This item was reviewed by the P&R Committee on August 1, 2019, and the Committee recommended for approval,

PCPS Director Ellis reviewed the agenda bill summary.

Agenda Bill #5237; A Motion authorizing the City Manager to execute utility relocation agreements with CenturyLink, Comcast, and Puget Sound Energy as part of the South 200th Street and Des Moines Memorial Drive (DMMD) Intersection Improvement Project (Public Works Project ST-065).

Summary: The DMMD South and South 200th Street Intersection Project will construct left turn lanes on all four legs of the intersection and a right turn lane on the east leg. Also, turning radii at the intersection will be sized to accommodate heavy freight, transit bus, and school bus traffic. Sidewalks and bike lanes will be extended to the beginning of the turn pocket transitions or approximately 300-feet in each direction. The existing span wire traffic signal will be replaced with a mast arm system and the street lighting will be upgraded. Curb ramps and pedestrian signals will be upgraded to meet current ADA and APS standards and the storm drainage system will be reconstructed as needed.

Puget Sound Energy (PSE) currently owns and operates the utility poles and electric distribution lines within the project area. PSE has worked with the City's design team to incorporate into the project replacement of PSE's existing overhead electrical distribution system with an underground system, removal of existing utility poles, and service

Agenda Bill #5237 (continued): connections to adjacent properties. With the removal of the utility poles, Comcast, and CenturyLink will also be required to underground their infrastructure. The proposed agreements memorialize the cost sharing, roles and responsibilities, and expectations related to this underground conversion work. The formula for payment of each utility's respective costs is pre-established through a franchise agreement or the utility's tariff, as further described below.

Puget Sound Energy: The sharing of costs related to undergrounding PSE facilities is set forth in their Puget Sound Energy: The sharing of costs related to undergrounding PSE facilities is set forth in their franchise agreement with the City. PSE will pay 60% of the civil infrastructure and underground electrical system costs and 100% of their project management costs. PSE is also responsible for ensuring that their utility poles are removed from the right-of-way. PSE's cost share is estimated at \$191,000.

CenturyLink: The sharing of costs related to undergrounding CenturyLink facilities is set forth in accordance with the terms of their tariff. CenturyLink will have SeaTac install their facilities and reimburse the City for their share of the associated costs. CenturyLink's cost share is estimated at \$97,000.

Comcast: The sharing of costs related to undergrounding Comcast facilities is set forth in their franchise agreement with the City. These agreements require Comcast to relocate and convert their aerial infrastructure to underground facilities at their own expense. Comcast will have SeaTac install their facilities and reimburse the City for their share of the associated costs. Comcast's cost chare is estimated at \$126,000.

This Motion authorizes the City Manager to execute utility relocation agreements in substantially similar form as presented in the packet.

It is estimated that the reimbursement revenue received from these utilities will be approximately \$414,000. However, actual reimbursements will be based on actual constructions costs.

This matter was presented to the T&PW Committee on August 1, 2019, and the Committee recommended approval.

City Engineer Cabudol reviewed the agenda bill summary.

MOVED BY KWON, SECONDED BY WACHTEL TO PASS AGENDA BILL #5237.*

CM Kwon stated this is just one part of the project. There should be some cost recovery for the City.
