**Holiday Closure:** City Hall and City facilities will be closed on Monday, January 17 in observance of the Martin Luther King, Jr. holiday.

Flag at half-staff to honor the victims of the tragedy in Tucson, Arizona: This past week flags at City Hall and City facilities were flown at half-staff in recognition and remembrance of the victims from the tragedy in Tucson, Arizona. President Obama directed that the flag of the United States of America be flown at half-staff from January 9 until sunset on Friday, January 14th, 2011.

Throughout the year, you may have noticed the flag at City Hall flying at half-staff several times. This is done in remembrance of the death of an armed forces member from Washington State while serving on active duty. Other government entities, citizens, and businesses are encouraged to join this recognition in honor of those service members

**2011 Master Recycler Composter Training:** Get ready for another Master Recycler Composter (MRC) annual training. After a year-long hiatus due to budget cuts in 2010, King County's Solid Waste Division is once again offering this valuable volunteer training. The MRC program is free and open to King County residents who live outside the City of Seattle. In exchange for the free training, program graduates are expected to volunteer 40 hours of outreach within two years in King County, outside of Seattle.

The MRC Program curriculum will address waste reduction, curbside recycling and food scrap collection, home composting, alternatives to household hazardous waste, solid waste impacts on climate change and tips on giving successful presentations. Veteran MRC volunteers are always welcome to attend any or all of the training sessions or tours. For veteran MRC volunteers it is a great way to receive current information about the Solid Waste Division's latest initiatives and also provides an opportunity to share their insight and brush up on presentation skills.

Training is set for Thursday evenings (6:30 – 9:00 PM) from February 10 through March 24, plus two Saturday sessions (9:00 AM – 3:00 PM) on February 12 and March 5 for tours and workshops. Evening sessions will be held in the ground floor conference rooms at the Kent Centennial Center located at 400 W. Gowe Street, Kent, WA.

Powerful Neighborhoods Program expanding to City of SeaTac - Participants get free compact fluorescent light bulbs installed: Starting this month, Seattle City Light will be expanding its Powerful Neighborhoods program to install free compact fluorescent light bulbs for residents of SeaTac served by that utility. The program will also be operating in the Burien and Tukwila areas.

Powerful Neighborhoods started in South Seattle in April as a pilot program designed to reach out door-to-door to seniors, non-English speaking households, low-income residents and other customers who might not have participated in energy conservation programs.

All installers have undergone background checks and drug-screening. Installers fluent in Spanish, Vietnamese, Tagalog, Amharic, Cantonese and other languages will be available to visit homes where those languages are primarily spoken. All staff will carry Seattle City Light identification.

Installers canvass neighborhoods door-to-door. If an interested resident is home, they install the energy efficient light bulbs and provide low-flow shower heads and faucet aerators or schedule a more convenient time to visit. If the resident is not home, installers leave a notice regarding how to contact the program to arrange a visit.

To qualify, a resident must live in a single-family home or 2 to 4 unit apartment or condo. To make an appointment, residents are directed to call the utility at 206.449.1132 or send an email to <u>SCL\_install@seattle.gov</u>.

**Somali Community Meeting:** The SeaTac Police Department and Tukwila Police Department sponsored a Somali Community Meeting on January 8, 2011 from 10:00 AM - 12:00 PM at the SeaTac Community Center. SeaTac Police Chief James Graddon, Captain Annette Louie and Tukwila Assistant Police Chief Don Lincoln provided information to the citizens. The meeting focused on public safety concerns within the Somali community. Based on the discussions, there were specific issues that appeared to be of interest that would improve the relationship and communication between law enforcement and the Somali community. It was apparent that language was a barrier and that this community wanted to be educated when they should be calling for emergency 911 public safety (police, fire and/or medical aid) responses or police intervention/education. We will be working on the following items:

- Somali translated instructions for calling 911
- Training on what the 911 system is and why to call
- Establishing a liaison between the Somali Community and the police agencies
- Identifying what issues young Somalis are getting in trouble for and provide some early education on those types of offenses
- Somali language anonymous "Crime Stoppers" type tip line
- Education on how law enforcement works
- Cultural diversity training for officers on the history of Somalia and Somalia
- Sidewalks/signs on Military Road between 150th and 154th

#### POWERFUL NEIGHBORHOODS PROGRAM EXPANDING TO SOUTHERN **SUBURBS**

Participants Get Free Compact Fluorescent Light Bulbs Installed

**SEATTLE** – Seattle City Light will expand its Powerful Neighborhoods program to install free compact fluorescent light bulbs in the areas of Burien, White Center, North Highlands, SeaTac, Tukwila and Skyway served by Seattle City Light starting Jan. 3.

Powerful Neighborhoods started in South Seattle in April as a pilot program designed to reach out door-to-door to seniors, non-English speaking households, low-income residents and other customers who might not have participated in energy conservation programs.

"We want to remove any barriers that have kept people from taking steps to increase the energy efficiency of their homes so they can reduce their energy consumption and save money," Interim Energy Conservation Director Glenn Atwood said.

Response from customers has been overwhelmingly positive with more than 96 percent of those who completed a satisfaction survey saying that they would definitely recommend the program to their neighbors and friends. According to one recent participant, "The representatives were courteous, considerate and very time efficient."

In 2010, installers worked with more than 7,000 families to install nearly 140,000 compact fluorescent light bulbs. The energy savings adds up to more than 24 million kilowatt-hours and will save customers roughly \$2.2 million over the lifetime of the bulbs. That's about \$60 a year for the average household.

Seattle City Light is working with Ecos Consulting, Cascadia Consulting, the Environmental Coalition of South Seattle (ECOSS), and Working Green to hire and train installers, schedule home visits, and deliver and install the products.

All installers have undergone background checks and drug-screening. Installers fluent in Spanish, Vietnamese, Tagalog, Amharic, Cantonese and other languages will be available to visit homes where those languages are primarily spoken. All staff will carry Seattle City Light identification.

Installers canvass neighborhoods door-to-door. If an interested resident is home, they install the energy efficient light bulbs and provide low-flow shower heads and faucet aerators or schedule a more convenient time to visit. If the resident is not home, installers leave a notice regarding how to contact the program to arrange a visit.

- Overview of key factors affecting salmon health in the streams: stormwater volumes, water quality, streamside vegetation
- Plans for the 2011 CSI: Highline survey season

We'll also have a brief "thank you" recognition ceremony for the 2010 volunteers.
