PUBLIC HEARING (PH) & ACTION ITEM:

2020 Property Tax Levy

DM Hill opened the PH at 6:19 p.m.

Finance & Systems Director Pilo reviewed the agenda bill summary below.

Mayor Sitterley stated the A&F Committee unanimously chose to forward this item to Council for approval.

Council discussion ensued regarding the proposed levy rate, impact to the taxpayers, historical statistics of levy amounts since 1990, and new development adds to valuation base which decreases the levy rate.

There were no public comments.

DM Hill closed the PH at 6:32 p.m.

Agenda Bill #5270; An Ordinance #19-1022 authorizing the City's 2020 Property Tax Levy.

Summary: Cities must submit their authorized levy amounts to the King County (KC) Assessor's Office by December 2, 2019 for inclusion in KC's 2020 property tax roll. The KC Assessor's Office is not expected to certify the City's assessed valuation (AV) prior to their December 2, 2019 deadline.

The total estimated allowable statutory levy amount including new construction, estimates of refunds, and increases in utility valuations is \$22,799,826. Under the 101% limit factor, the allowable levy amount is currently anticipated to be \$17,754,823. This year's implicit price deflator (IPD) is 1.396%, which means the City could levy the full 1% increase, as allowed by statute, or bank this capacity for future use without adopting a separate resolution for substantial need. In 2018, the Council adopted Financial Policies, including a policy establishing that as long as the

Agenda Bill #5270; Ordinance #19-1022 (continued): General Fund (GF) Reserves are within the set reserve target (4 months), the City will not increase its property tax levy. Therefore, a 0% increase over the 2019 amount plus revenue from new construction has been applied in development of the mid-biennium review.

The KC Assessor has given the City a preliminary estimate of the City's 2020 assessed value equal to \$6.9 billion, a 4% increase over 2019. This preliminary estimate excludes any increases in utility valuation. Because the actual 2020 levy rate is calculated from the KC certified AV, the final rate is unknown at this time. However, based on the City proceeding with a 0% increase, it is anticipated the levy rate will decrease from \$2.566/\$1,000 AV levied in 2019 to \$2.491/\$1,000 AV for 2020. This decrease in levy rate translates to a \$7.40 decrease in property tax per \$100,000 AV. The actual increase or decrease in property taxes is dependent upon the actual change in a particular property's AV.

This Ordinance authorizes a 2020 property tax levy amount of \$17,326,928 based on a rate of \$2.491/\$1,000 AV and a 0% increase over the 2019 levy. The actual levy amount will be determined when the KC Assessor certifies the City's total assessed valuation in December.

This was reviewed by the A&F Committee on October 17, 2019. The required PH is scheduled for October 22, 2019.

ACTION ITEMS:

Agenda Bill #5305; A Motion authorizing the City Manager to accept \$338,400 awarded from the 2018 Community Development Block Grant (CDBG) program to constructPhase Two of the Riverton Heights Neighborhood Park, and execute any agreements necessary to accept the grant.

Summary: The City was awarded \$338,400 to construct Phase Two of Riverton Height Neighborhood Park Project. This will include expansion of the basketball court, installation of the playground area for preschool aged children, and installation of an irrigation system. In 2007, the City purchased the Riverton Heights Elementary School site from the Highline School District, and after the City cleared the buildings and completed the necessary environmental cleanup, the community adopted the site as an informal park.

The City was awarded funds through the 2016 Community Development Block Grant (CDBG) to design and construct Phase One of the Riverton Heights Neighborhood Park Project. This included installation of a basketball court, signage, upgrade to the existing parking lot, benches, a pathway and installation of playground equipment. Phase One was completed in 2017.

It is anticipated that the design phase of the project will begin this year and the construction phase will begin in spring, 2020. The construction of this project is fully funded by the CDBG and will have no fiscal impact to the City.

The 2019-2020 biennial budget included \$160,291 in grant money for the project. Acceptance of the grant will increase revenues in the Municipal Capital Improvement Fund by \$178,109.

This item was discussed at the October 3, 2019, Parks and Recreation (P&R) Committee meeting and the Committee recommended approval to accept the funds.

Parks Projects & Operations Manager Fitzpatrick reviewed the agenda bill summary.

MOVED BY FORSCHLER, SECONDED BY WACHTEL TO PASS AGENDA BILL #5305.*

DM Hill stated this was reviewed by the P&R Committee.

Council commented on the success of phase 1 and thanked staff for their efforts.

ACTION ITEMS (continued):

Agenda Bill #5325; A Resolution #19-014 of the SeaTac City Council declaring its intent to designate its defined Urban Center as a Residential Targeted Area pursuant to RCW 84.14.040, and establishing a date and time for a public hearing (PH) to consider this matter.

Summary: RCW 84.14 authorizes cities to establish processes to provide for limited exemptions from ad valorem property taxation for qualified new multi-family housing. The City established its current Multi-family Tax Exemption (MFTE) program in 2008. Currently, only the South 154th Street Station Area is so designated. The Council is being asked to consider expanding the "Residential Targeted Area" to include the entire Urban Center as defined in the City's Comprehensive Plan (CP). The Urban Center includes the three light rail stations serving the City.

RCW 84.14.040 requires the City to conduct a PH prior to taking action to establish a new "Residential Targeted Area." This Resolution meets the requirements of state law by declaring its intent to designate the entire Urban Center as a Residential Targeted Area. Additionally, this Resolution sets a PH for the Council to consider this issue at the November 12, 2019 Regular Council Meeting (RCM).

This Resolution is not a vote for or against whether the expansion of the Residential Targeted Area is appropriate. Instead, such discussion would occur on the November 12, 2019 RCM.

Any fiscal impact regarding the expansion of the Residential Targeted Area will occur at the November 12, 2019 RCM.

This Resolution has not been before committee, as the need for this Resolution was not apparent until the Ordinance review process. However, this issue has been discussed over the past 6+ months at the Planning & Economic Development (PED) Committee; the tax implications were reviewed by the A&F Committee on September 12, 2019. At its September 26, 2019 regular meeting, the PED Committee voted 3-0 to recommend approval of expanding the program to include the entire Urban Center.

CED Director Pilcher reviewed the agenda bill summary,

CM Wachtel commented on PED Committee review and stated this will not take money from the residents.

Mayor Sitterley commented on A&F Committee review.

CM Tombs stated he has received calls from residents who have heard rezoning rumors around Bow Lake Mobile Home Park. He clarified the process and request.

DM Hill stated that he will be representing the City at the Glacier Middle School Grand opening and the Washington Council for the Blind Convention.
