1. Call to Order	Chair Fernald called the meeting to order at 6:00PM
2. Public Comment	<u>Comment:</u> No public comment.
3. Review of 10/10/19 Minutes	<u>X</u> Approval  Committee approved the meeting minutes as written.
4. FD Cares	<u>X</u> Discussion – Aaron Tyerman with PSRFA gave a presentation on the FD Cares program. FD Cares is staffed by a nurse and Firefighter, along with 3 social workers that provide services for the low acuity 9-1-1 calls. They provide person assessments and connect those patients with the right resources. FD Cares is launching a new core service called Mobile Integrated Health, which utilizes an IT Infrastructure that connects and coordinates health, behavioral, and social services in the community. The FD Cares Unit runs 12/hr a day, 7 days a week, but referrals are 24/7.  Discussion / Questions followed.
5. Graffiti and Gangs	<u>X</u> Discussion – MPO Kevin Bugosh gave a presentation on graffiti associated with gangs and gang related stats in SeaTac. There has been a spike in graffiti near Madrona Elementary and there is a DPM (Directed Patrol Mission) for the apartments in that area. Kevin stated that gang tagging lets police know the areas where gangs are active. Tagging needs to be documented and removed immediately because it could lead to serious gang-related incidents. Chief Mattsen said there is a WAGang database that allows gang information to be shared with other surrounding law enforcement agencies.  Discussion / Questions followed.

6. PD Roles: Immigration Issues	<p>X Discussion – Chief Mattsen stated that WA State was declared by Gov. Inslee to be a sanctuary state earlier in the year, King County is a sanctuary county, and Seattle is a sanctuary city. KCSO will assist with ICE when there is a warrant, but they are prohibited by policy to assist ICE with immigration issues via a “Detainer”. They only deal with the crimes that are before them.</p> <p>Discussion / Questions followed.</p>
7. Motel 6 Stats	<p>X Discussion – Chief Mattsen gave an update on the Motel 6 stats. In the past year, at S 165<sup>th</sup> / Int’l Blvd, there were 780 CFS, 55% were officer initiated; at S 206<sup>th</sup> / Military Rd S there were 706 CFS, 66% were officer initiated; and at S 189<sup>th</sup> / 47<sup>th</sup> Ave S there were 523 CFS, 62% were officer initiated. Officers are very proactive in curbing criminal activity at these motels. There has been an increase in prostitution at hotels since backpage and Craigslist have been shut down. Hotels are having staff be trained to identify human trafficking.</p> <p>Discussion / Questions followed.</p>

**DRAFT language for  
Vehicle Impound  
Ordinance**

## Parking on municipal property

A. Generally. No person shall stop, stand or park a vehicle in any garage, parking area or other property operated by the City, where signs prohibit or restrict such stopping, standing or parking without lawful authority or permission. Any motor vehicle so stopped, standing or parked on municipal property for a period of \_\_\_ hours or more without authority or permission is a nuisance.

B. Municipal Parks and Trails. No person shall stand, stop or park a vehicle in any municipal park or trail areas except in areas designated for such purposes. No person shall stand, stop or park any vehicle in a parking stall designated for a municipal park or trail area for a period of time exceeding the maximum amount of time permitted as posted or, if a time limit is not posted, for a period of time exceeding \_\_\_ hours, without lawful permission or authority

### Enforcement:

A. The Public Works Department or designee is authorized to place and maintain traffic control devices, including signs indicating parking restrictions, as deemed necessary to regulate, warn, or guide traffic under any parking or travel on roadways, highways and intersections in the City.

B. For the purpose of issuing infractions under this Chapter, the Chief of Police may designate other individuals, including individuals not commissioned as police officers, to enforce Parking regulation and issue citations to violators as provided therein.

### Penalties and impound procedures:

A. Violations of the provisions of this Chapter 9.20 are parking infractions punishable by monetary penalties of not more than \$\_\_\_ and/or impoundment.

B. Impound Authorized. Any vehicle parked on any City right-of-way or City owned, leased or operated property this Chapter is subject to citation by a law enforcement officer and/or impoundment in accordance with this chapter by the law enforcement officer or a public official having jurisdiction over the right-of-way or property upon which the vehicle is located. *-this language would give Parks and Parking enforcement officers the authority to call for an impound*

C. Immediate Impound. Vehicles parked in violation of this Chapter are subject to immediate impound under the following circumstances:

1. When the vehicle is impeding the normal flow of vehicular or pedestrian traffic; *-we already have this language somewhere in our code*

2. *When the vehicle is parked in violation of a parking restriction sign or when the vehicle is interfering, or is likely to interfere, with the intended use of the restricted parking zone; or -we need to add similar language in our code*
