



## City Manager's Weekly Update

**Seahawk send off celebration:** On Friday, January 14, numerous Seahawk fans came out to Valley Ridge Park in SeaTac to cheer on the team as they departed for their divisional round playoff game in Chicago. The Seahawk mascot Blitz was on hand giving out rally towels and signs to fans. Coffee and donuts were also provided by the Seahawks. Many fans were wearing the team colors. The team buses came through and the crowd cheered loudly and waved signs wishing them good luck against the Chicago Bears.

**Life Saving CPR:** On January 1 at 08:01 AM, SeaTac Fire Engines 45 and 46, Battalion 45 and King County Medic One responded to the 19700 block of 34th Avenue S. for an 81 year old female who was in cardiac arrest. CPR had been initiated by a citizen. Crews quickly took over CPR, attached the defibrillator, analyzed the rhythm and administered a shock. The patient's heart responded and converted back to a good rhythm. Medic One provided advanced life support and transported the patient to Highline Community Hospital.

**SeaTac Assists North Highline with Structure Fire:** On January 1 at 10:18 AM, SeaTac Fire Engine 47 responded mutually with the North Highline Fire Department for a residential structure fire in the 1200 block of S. 132nd Street. Engine 47 arrived after North Highline and assisted with extinguishing the house fire.

**Mobile Home Fire:** On January 17 at 1:32 PM, SeaTac Fire Engines 45, 46, 47, Battalion 45 and Port of Seattle Engine 711 were dispatched to a mobile home fire. Initially the occupants had noticed that their dishwasher was smoking and they could hear fire crackling sounds. Crews located the source of the fire under the floor area in the crawl space. The fire was quickly extinguished and the cause of the fire was determined to be an electrical short circuit. There were no injuries and damage is estimated at \$8,500.

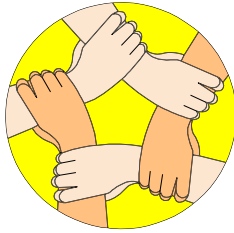
