- (4) heard from the City's Lobbyist, the City should receive \$875,000 from the state

#### **ACTION ITEMS:**

Agenda Bill #5363; A Motion authorizing the City Manager to execute a contract with Judha of Lion Landscaping and Services LLC for the construction of the Valley Ridge Park (VRP) Entry Way Improvements. Summary: The scope of work for the VRP Entry Way Improvements includes, but is not limited to, the removal of natural grass adjacent to the entry way and replacing with concrete, importing new topsoil, replacing trees that have been in poor condition since 2007, installation of irrigation, and installing benches. In addition, a bid alternate for replacing the cracked existing concrete of the entryway was included in the bid packet. The work performed consists of furnishing all labor, tools, materials and equipment necessary for construction. These improvements will enhance the entry way of the VRP that hosts numerous sporting events and state-wide tournaments.

The Call for Bids for construction was submitted to the Small Works Roster and the bid deadline was March 12, 2020. The City received six bids and Judha of Lion Landscaping and Services LLC is the low bidder.

Due to the COVID-19 pandemic, the anticipated start date of construction will not be determined until further notice. Per the construction contract, the project is schedule to be completed in 60 working days after the contractor receives a Notice to Proceed.

The cost of this project, including sales tax and a 10% contingency, is \$199,353 with the bid alternate and \$190,882 without the bid alternate. The funding was carried over in 2019 and 2020 from the VRP Improvement project.

This item was presented to the P&R Committee in February but due to the COVID-19 pandemic, the April P&R Committee was canceled prohibiting the committee from reviewing the six bids and making a recommendation.

PCPS Director Ellis reviewed the agenda bill summary.

CM Hill reviewed the February P&R discussion.

Council discussion ensued regarding the project: whether the City has used this company before, variation of bids, and ADA compliancy.

\*MOTION CARRIED UNANIMOUSLY.

Agenda Bill #5414; An Ordinance #20-1008 adopting a Complete Streets Policy and approach to the design and implementation of transportation projects in the City of SeaTac.

Summary: A Complete Streets Policy provides an approach for planning, designing, and building streets that use context sensitive solutions to accommodate all users, including pedestrians, transit users, cyclists, and motorists. A draft Safe & Complete Streets Plan was developed in 2011. It was endorsed through Resolution 12-002 and referenced in development of the 2015 Transportation Master Plan. The Plan outlined goals for the development of SeaTac's pedestrian and bicycle network through the year 2040. Recommendations were identified in the plan, some of which were integrated into the Transportation Master and Comprehensive Plans. Although the Safe & Complete Streets Plan was endorsed by Resolution, it was never formally adopted through Ordinance.

The Complete Streets approach considers the goals of the community and aligns them with transportation safety and mobility goals. Most of the elements consistent with a Complete Streets approach to design have already become current standard practice in Public Works planning and engineering and align well with Council's mission to have a healthy city and improve community safety. Complete Streets also leverages the City's goal of infrastructure investment to meet this mission. While the City currently implements Complete Street practices, SeaTac will be at a disadvantage competing for some transportation funding sources if a Complete Streets Policy is not adopted by Ordinance. The proposed Ordinance formally adopts a Complete Streets Policy that reflects City practices today and will increase grant eligibility.

This topic has been before the T&PW Committee on October 18, 2018 and February 6, 2020. On February 6, 2020, the T&PW committee recommended sending this item to Council for review and adoption.

City Engineer Cabudol reviewed the agenda bill summary.

MOVED BY KWON, SECONDED BY WACHTEL TO PASS AGENDA BILL #5414 (ORDINANCE #20-1008).\*

DM Kwon reviewed the T&PW Committee discussion.

A question was posed about horse crossings. Mr. Cole stated horses follow same rules as cars so no additional rules would be needed.

**UNFINISHED BUSINESS:** None

**COUNCIL COMMENTS:** CM Wachtel stated he received an email from a resident stating a CM noted in a public forum they had contacted representatives from the state advocating support of some type. City attorney Mirante Bartolo stated she would discuss this further offline with CM Wachtel and determine if anything needs to be done.

DM Kwon commented that while the Governor has relaxed restrictions for some outside recreation, residents should continue to be careful as SeaTac's numbers for confirmed cases continues to rise.

CM Hill reminded everyone that SeaTac is an International City with visitors arriving by plane and residents should care of themselves.

**COUNCIL COMMENTS (continued):** CM Gobena stated SeaTac has one de-intensifying structure. He questioned what that will look like as the Stay home. Stay healthy, order is relaxed more. Mr. Cole stated this structure is to house homeless who are not infected. They are allowed to walk around just like anyone else. CM Gobena also encouraged everyone to take care of themselves.

CM Fernald encouraged everyone to continue following all of the guidelines and stay safe. She also thanked IS Manager Bart Perman for his assistance getting set up for this meeting.

Mayor Sitterley stated she received an email from resident Earl Gipson stating the Council looks good online. Mayor Sitterley stated IS Manager Perman has done a great job with the City's virtual meetings.

CM Gobena also thanked Mayor Sitterley for approving the Against Discrimination During the COVID-19 Pandemic Proclamation.

Whereas, working together to educate our community about sexual violence, supporting survivors when they come forward, speaking out against harmful attitudes and actions, and engaging in best-practice sexual violence prevention work helps end sexual violence.

Now, therefore, I, Erin Sitterley, Mayor of the City of SeaTac, on behalf of the City Council, do hereby proclaim April 2020, as Sexual Assault Awareness Month in SeaTac.
