PROJECT NAME: SeaTac Parks, Recreation and Open Space Plan (PROS Plan) update and related amendments to the SeaTac Comprehensive Plan.

PROJECT LOCATION: Citywide

PROJECT DESCRIPTION: Updates to the SeaTac Parks, Recreation and Open Space Plan (PROS Plan) and related amendments to the SeaTac Comprehensive Plan including:

- Creation of a community supported parks, recreation and open space vision
- Inventory of parks facilities, recreation programs and users, and needs and trends
- Updates to some goals, objectives, recommendations and actions
- Land Use Element: Removing one implementation strategy regarding community gardens that is addressed elsewhere in the current PROS proposal
- Parks, Recreation & Open Space Element: Updates to policies on parks and recreation facility levels of service, park facility acquisition, and wayfinding and signage, in order to better reflect community engagement priorities and ensure alignment with other Comprehensive Plan policies.
- Capital Facilities Element & Background Report: Updates to level of service standards
