

## PRESENTATION OVERVIEW

#### **PURPOSE OF PRESENTATION**

- Address City Council
  questions related to the use
  of lodging tax revenues
- 2. Provide an overview of the City's oversight role of the Seattle Southside Regional Tourism Authority (SSRTA)
- 3. Recommend an approach to address future City Council concerns

#### WHY IS THIS ISSUE IMPORTANT?

- Annual approval of the Seattle Southside Regional Tourism Authority (SSRTA) budget by the City Council is required
- The SSRTA budget incorporates lodging tax revenues that receive a separate approval by the City Council
- 3. The City Council has indicated that it desires to ensure that lodging tax monies are being used to provide the best value to the SeaTac community
- 4. The proposed motion would define "best value" for use in evaluating lodging tax expenditures in future budget decisions

- Overarching question: Is the SeaTac community getting a good value on the expenditure of its lodging tax dollars?





## PRESENTATION OVERVIEW - Tourism Promotion Area

#### Tourism Promotion Area (TPA) – Attachment / Exhibit 1A

- Formed jointly by the Cities of SeaTac, Tukwila, and Des Moines
- Funded through a self-assessment of \$2/night by hoteliers
  - Revenues are directed to the SSRTA, which is chartered by SeaTac
  - The SSRTA was formed to manage and operate the TPA
  - Revenues are used to promote tourism
- SeaTac is responsible for approving the SSRTA's budget and the use of the TPA special assessments
- The SSRTA budget may also include "Lodging Tax" revenues, which are authorized separately



## PRESENTATION OVERVIEW – Lodging Tax

Lodging Tax – Attachment / Exhibit 1B

- 1% tax assessed on hotels intended to fund tourism related activities & facilities
- Lodging tax revenues allocation:
  - Hotel / Motel Advisory Committee (HMAC) reviews "applications" and makes a recommendation to the City Council on applicants and funding amount
  - City Council may accept recommendation <u>or</u> may choose to not fund a recommended applicant; Council may choose to fund at different amounts
  - 45-day comment period for HMAC if City Council chooses to not fund a application at the recommended amount
  - City Council may only allocate lodging tax revenues to applications that have received a recommendation of approval from HMAC
- SSRTA has historically applied for, and received, Lodging Tax money





## PRESENTATION OVERVIEW – Oversight, Motion, Next Steps

City Oversight, Motion, and Next Steps

- Current City oversight:
  - Approval of the SSRTA budget related to TPA self-assessment expenditures
  - Approval of the Lodging Tax expenditures, including those related to SSRTA applications
- Developing SeaTac-specific performance metrics would allow the City Council and community to develop a strategic approach to determining whether the community is receiving a good value
- Next Steps:
  - November 10 City Council action on 2020 Amended SSRTA budget
  - November 24 City Council action on 2021 SSRTA budget
