CALL TO ORDER: Mayor Erin Sitterley called the SeaTac City Council Regular Meeting to order at 6:00 p.m.

Steve Huff thanked the City Council for this honor.

33rd Legislative District Legislative Overview/Preview 2021 Session.

Government Relations & Communications Manager Moore introduced 33rd District Senator Karen Keiser and 33rd District Representatives Tina Orwall and Mia Gregerson.

Ms. Keiser, Ms. Orwall, and Ms. Gregerson provided a preview of the 2021 Session. The pandemic and financial recession at the same time will cause budget restrictions. They commented on the Public Health Quality and Air Quality studies, what schools need, technology, housing partnership, daycare facilities, police reform, plastics, and voting.

Discussion ensued regarding delaying the fine particle testing indoors when the airport is not at full capacity due to the pandemic, thanked Senator and Representatives for their services, siting of a second airport, and additional time needed for the siting due to the pandemic.

PRESENTATIONS (continued):

Puget Sound Regional Fire Authority (PSRFA) Update

PSRFA Deputy Fire Chief Aaron Tyerman presented the quarterly performance report for Quarter 3, quarter to date through September 13, 2020, including Area Call Volume versus All RFA – down for the total number of calls for the PSRFA and the City of SeaTac; Top 10 Call Types - #1 call type is EMS related; Responses by apparatus – E345 is still the busiest, but numbers have gone down; and FD Cares responses.

He also reviewed the following regional updates: community testing sites in Auburn opened in September, and Tukwila and Federal Way will open in October; PSRFA Update – wild land fires, Assistant Chief Tomlinson retired; and SeaTac Update – Deputy Chief Brian Carson was promoted to Assistant Chief Tomlinson's position.

Council discussion ensued regarding: call volume decreasing (common in the US, directly related to COVID), thanks for Deputy Chief Tyerman's service, COVID testing sites, and FD Cares.

PUBLIC HEARING (PH):

Interim Regulations on Flood Damage Prevention and Flood Hazard Areas Mayor Sitterley opened the PH at 7:42 p.m.

PW Director Appleton stated the interim emergency Ordinance was put into place to ensure the City remained in compliance with the national flood insurance program. Minimum requirements were adopted. In order to keep the Ordinance in place through December 31, the Council is required to have a PH. The final language is being developed.

DM Kwon stated the T&PW Committee reviewed the emergency Ordinance and had unanimous recommendation to approve moving it forward to Council. This is a procedural step.

Public Comments: None

Mayor Sitterley closed the PH at 7:48 p.m.

ACTION ITEMS:

Agenda Bill #5562; An Ordinance #20-1015 authorizing the City Manager to purchase laptop computers in order to facilitate remote working capabilities for City employees and amending the 2019-2020 Biennial Budget

Summary: In order to ensure that City employees have the necessary equipment to work remotely, it is necessary to purchase additional laptop computers. It is proposed that the City purchase laptop computers to replace existing desktop computers for City staff.

The new laptop computers would be purchased through the State contract in an amount not to exceed \$188,000 and would be funded through the CARES Act.

Purchases using CARES Act funding must be acquired by October 31, so bringing this item to committee would not allow enough time to acquire the computers prior to this deadline.

IS Manager Perman reviewed the agenda bill summary.

Agenda Bill #5403; An Ordinance #20-1016 amending SeaTac Municipal Code (SMC) Chapter 9.20 related to vehicle impoundment, redemption, and impoundment hearings.

Summary: Unauthorized vehicles parking on City property is an ongoing concern. Although City staff have initiated the removal of vehicles in violation of the posted time restrictions at various City properties (i.e. the SeaTac Community Center, Angle Lake Park, and City Hall), the City has not prevailed when such removals have been challenged in an impoundment hearing. Even though City staff acted under the mistaken belief that they had authority to authorize the removal of vehicles on City property, the Court noted that no such authority existed under the SMC. This has created a dilemma for the City because abandoned vehicles have sometimes remained on City property for several weeks and have become the target of criminal activity. Airport passengers have also utilized City property as a type of park-and-fly facility.

Currently, SMC authorizes law enforcement to impound vehicles on City property. However, the policy of the King County (KC) Sheriff's Office (KCSO) only allows officers to impound vehicles if the impoundment is specifically authorized under State law (e.g., disabled parking areas, fire lanes, etc.). Time restrictions alone do not provide SeaTac Police sufficient grounds to impound a vehicle under the County's policies. This Ordinance authorizes the City Manager to designate City staff to initiate impoundment of illegally parked vehicles in order to protect City property from improper use and to prevent property from attracting criminal activity.

Notice requirements and the impoundment procedures under this Ordinance will align with the corresponding provisions of the Revised Code of Washington (RCW) so that the City's provision reflect state law. This Ordinance references the RCW sections related to vehicle impoundment, which clarifies the impoundment procedure and process for the redemption of an impounded vehicle.

Lastly, this Ordinance authorizes impoundment hearings be conducted in SeaTac Municipal Court when the tow is initiated by City staff. Currently, the City Code directs all vehicle impoundment hearings be conducted in KC District Court.

This Ordinance was initially presented before the PS&J Committee on January 9, 2020, and again on September 10, 2020. The Committee recommends approval of this Ordinance.

Assistant City Attorney Corsilles reviewed the agenda bill summary.

MOVED BY NEGUSSE, SECONDED BY FERNALD TO AMEND SECTION 9.20.080(H) BY STRIKING OUT THE WORDS "REGARDLESS OF WHETHER" AND INSERTING THE WORD "IF" AND STRIKING THE WORDS "OR UNLAWFUL".

ACTION ITEMS (continued):

Agenda Bill #5420; An Ordinance #20-1017 adding new Sections to Chapter 9.05 of the SeaTac Municipal Code (SMC) relating to parking restrictions and enforcement at City-owned properties.

Summary: There is no current City Code regulating parking on City property. Existing signage currently limits parking to a specific number of hours that varies in different City locations. However, the SMC does not provide for the creation or enforcement of these restrictions. This Ordinance establishes the authority for regulating parking on City property. Moreover, where no parking limit is posted, this Ordinance now restricts parking on City property to a maximum of twenty-four (24) hours.

Currently, the SMC does not provide authority for the creation or enforcement of parking restriction on City property. Therefore, this Ordinance authorizes the City Manager (or designee) to establish restrictions for parking on City property. The City Manager (or designee) would also be authorized to designate City employees who can enforce parking regulations on City property. Violation of the parking restrictions would result in a parking infraction with a \$50.00 penalty. These parking infractions may be contested in SeaTac Municipal Court.

This Ordinance was presented to the PS&J Committee on September 10, 2020, and the committee recommended approval.

Assistant City Attorney Corsilles reviewed the agenda bill summary.

MOVED BY FERNALD, SECONDED BY NEGUSSE TO PASS AGENDA BILL #5420 (ORDINANCE #20-1017).*

Council discussion ensued regarding the infraction ticket, signage, and 24-hour period.

Agenda Bill #5534; A Motion authorizing the City Manager to execute an agreement with Kent School District for the Stormwater Drainage and Sanitary Sewer easements at Grandview Park.

Summary: The Kent School District is constructing the new Valley Elementary School at 22420 Military Road South. In order to provide sanitary sewer and stormwater drainage conveyance for the school, the School District requested easements through Grandview Park.

Through a series of discussions between the City and School District staff, and reviews of site restraints and possible alignments with the P&R Committee (July 8, 2019, and September 5, 2019), an alignment for these easements was determined. The PW Department reviewed the proposed alignments and provided a supportive recommendation regarding the approval of the easements to the P&R Committee at its December 5, 2019, meeting. Following that meeting, the committee forwarded this item to Council with a recommendation for approval.

At the June 23, 2020, Regular Council Meeting (RCM) the City Council approved Resolution #20-008 for the alignment and extent of the sanitary sewer and storm water drainage easements within Grandview Park for the Kent School District. The Resolution also authorized the City Manager to negotiate the compensation to be received for the value of the easements. However, a final agreement must be approved by the City Council.

The Agreement provides that the School District will pay the City the appraised market value of \$128,300 in exchange for granting the two easements. The stormwater drainage easement will be granted to the School District, and the Sewer Easement will be granted to the Kent Sewer District because they are the entity providing sewer service to the school.

The P&R Committee recommended the alignment of the sewer and stormwater easements move forward to Council on December 5, 2019. Council approved Resolution #20-008 on June 23, 2020. At the September 3, 2020, P&R Committee meeting, the committee did not recommend the approval for the design and construction of a permanent restroom facility in lieu of monetary payment. Staff did not revisit the alignment of the easement.

PW Director Appleton reviewed the agenda bill summary.

Agenda Bill #5507; A Resolution #20-011 amending the City Council Administrative Procedures.

- 2. Remove the schedule for Airport Advisory Committee (to be sunsetted in the Citizen Advisory Committee Ordinance revisions).
- 3. Remove the 4th Thursday meeting for A&F Committee.
- 4. Change the PED Committee meeting schedule time.

- 1. Clarification language and housekeeping changes
- 2. Revise Proclamations language

Section 6. Miscellaneous Agenda Procedures.
