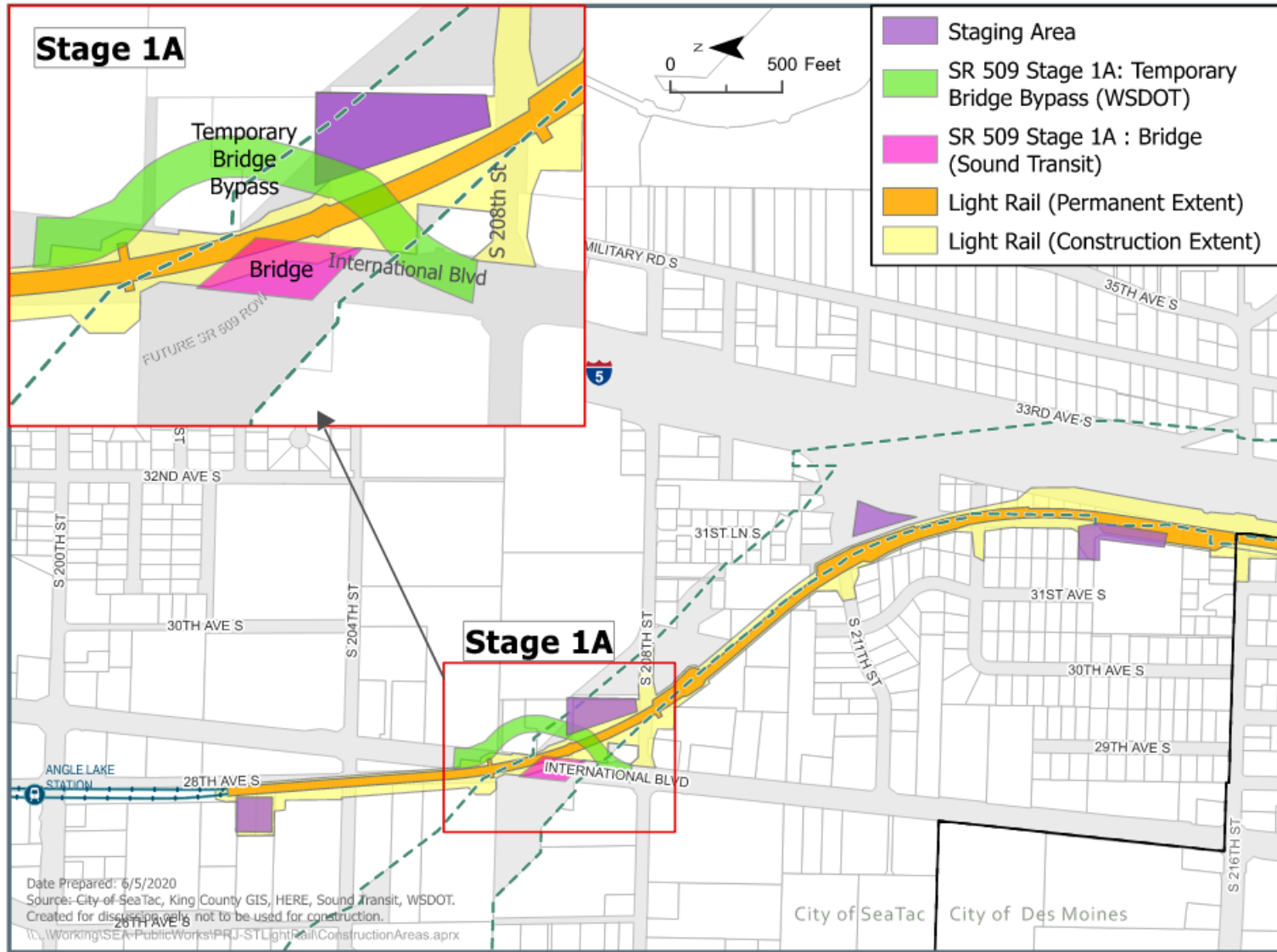

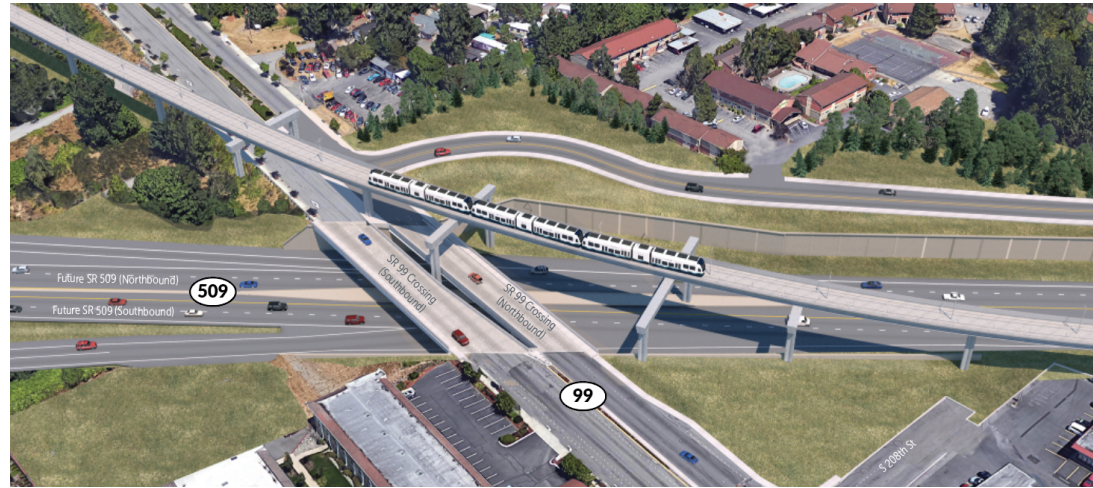

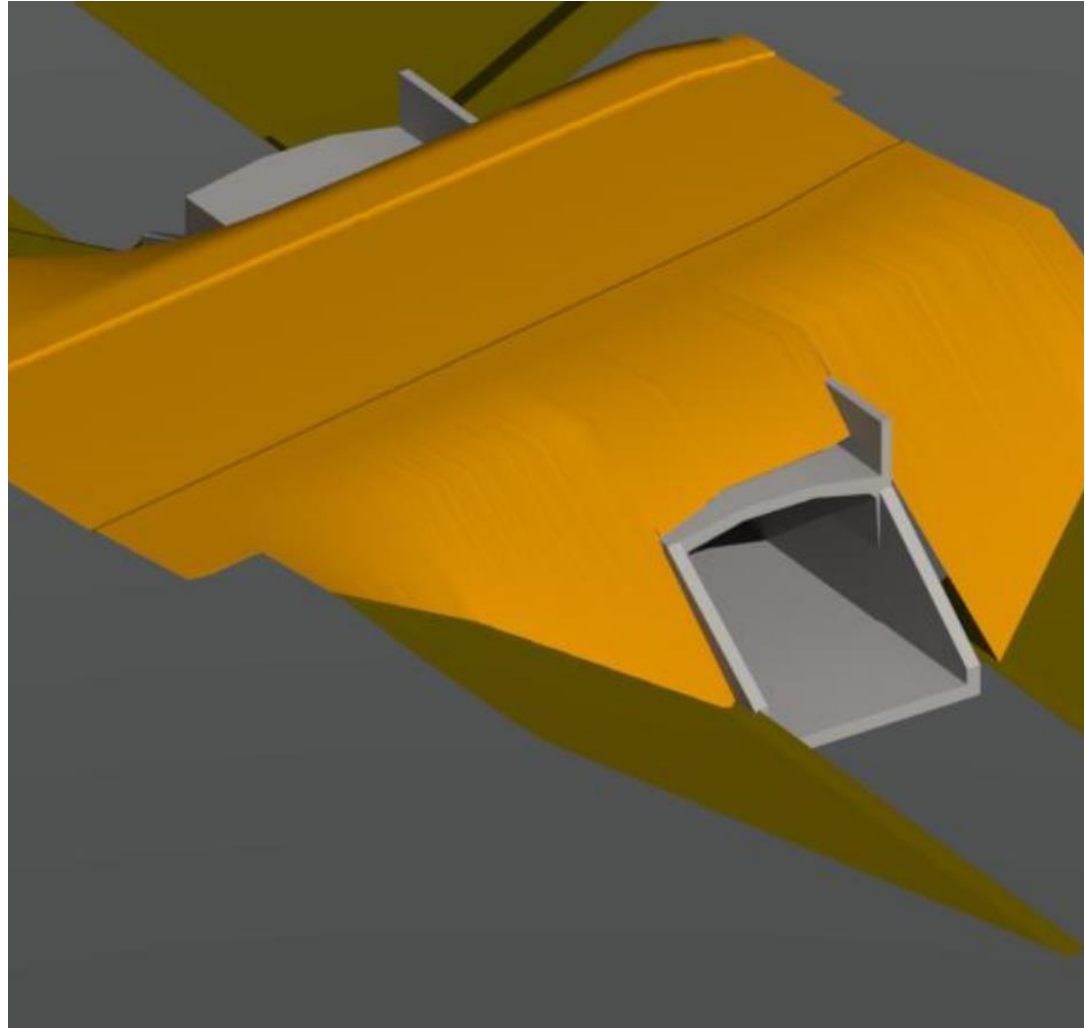

## **Purpose:**

The purpose of this item is to report on the completion of the South 166<sup>th</sup> Street Safe Routes to School project, its benefits to the community, and seek recommendation approve final acceptance of the project.

## **Background:**

The South 166<sup>th</sup> Street Safe Routes to School project (PW Project ST-N78) constructed curb, gutter, and sidewalk from 34th Avenue South to Military Road South to provide a safe route for pedestrians to access McMicken Heights Elementary and other nearby destinations. The project is approximately 2,900 feet long and included new ADA compliant curb ramps, a Rapid Rectangular Flashing Beacon (RRFB) crosswalk, all-way stop signs with LED flashers, speed radar feedback sign(s), landscaping, pedestrian lighting and storm drainage improvements.

Tucci & Sons, Inc. was awarded the contract on 7/24/2018 and project physical completion was achieved on October 25, 2019. Actual construction expenditures totaled \$2,724,237.76, which was under the authorized expenditure amount of \$2,731,796. The project was partially funded through a federal Safe Routes to School grant of \$967, 200.

The one-year warranty period is now complete and staff is proceeding with requesting Council action granting Final Acceptance of the project. Issuing Final Acceptance officially indicates the City's acceptance of the project. After issuing Final Acceptance, the process of filing a Notice of Completion with the State's Department of Revenue, Department of Labor and Employment Security Department can be initiated in compliance with RCW 60.28.051. The Notice of Completion certifies that any applicable taxes, premiums, funds, and penalties have been paid by the Contractor and therefore the Agency is authorized to release any associated retained funds or bonds.

## **Options/Recommendation:**

Staff is seeking Committee recommendation to forward the final acceptance of this project to Council for approval.

# Final Acceptance of Public Works Contract

## Consent Agenda Approval Request

Pursuant to Resolution #15-014, Final Acceptance of public works contracts can be approved by the City Council via Consent Agenda when total costs are within the total authorized expenditure. If the contract costs exceed the authorized amount then an Agenda Bill is required to approve Final Acceptance and increase expenditure authorization.

A presentation of project before and after pictures is required for capital improvement projects greater than \$1M and at the request of the City Manager. The presentation is to occur at the same Regular Council Meeting as the Consent Agenda Approval Request. A presentation is not necessary for in-kind preservation, repair, or replacement projects within the authorized expenditure amount

### Instructions:


1. Upon completion of all contract work, the project manager from the contracting department completes all sections except "Date of Council Approval".
2. The project manager emails the completed form in pdf form to the City Clerk's Office. [cityclerk@ci.seatac.wa.us](mailto:cityclerk@ci.seatac.wa.us).
  - a. If no presentation, the form is due by 5 p.m., the day before the Council packet is published.
  - b. If presentation is required, deadline for placement on the agenda is noon, two Wednesday's prior to packet (unless there's a holiday). The form would still be due by 5 p.m., the day before the Council packet is published.
3. Upon Council approval, the project manager enters the "Date of Council Approval" and the form is placed in the project file.





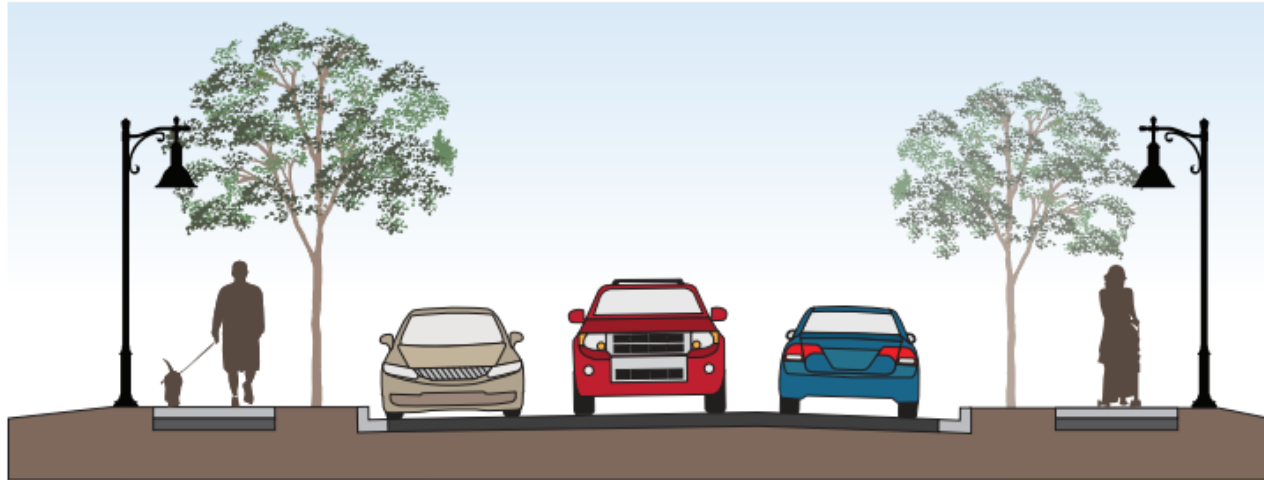

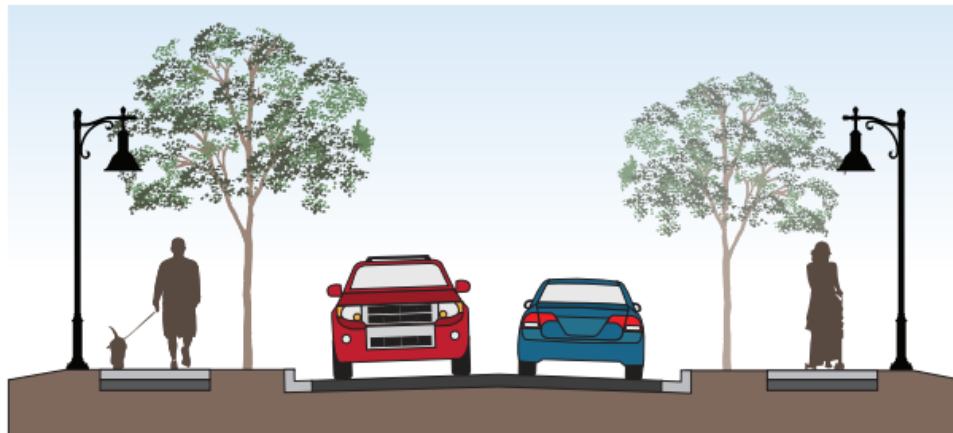

## **Purpose:**

To provide an overview of trash/litter removal operations within the City.

## **Background:**

The removal of trash/litter from our rights-of-way (ROW) is a priority for our maintenance and operations crews. Public Works recognizes that maintaining a clean ROW is critical in projecting a positive image of our Community to the traveling public and in helping to minimize environmental and storm water impacts within our region.

Challenges include:

- High daily influx of people into our community
- Littering from moving vehicles
- Littering from Pedestrians
- Illegal dumping of debris
- Ensuring adequate maintenance of public rubbish bins
- Public education around littering

Removal of litter from the ROW requires extreme caution to be taken and safety procedures followed due to the presence of vehicular traffic and due to the nature of the trash itself at times (sharp objects, etc.). Crews hand pick litter within the ROW in addition to using a street sweeper to remove debris from the curb and gutter line. When observed or notified, Public Works crews remove material intentionally dumped or abandoned within the ROW as well. Crews will not go onto private property to remove litter. Public Works uses the following approaches to address trash in the ROW:

- Once a week emphasis on litter removal (Mondays)
- Coordination with Waste Hauler on rubbish bin collections
- Coordination with Transit Authorities on rubbish bin collections
- Employment of seasonal workers to allow for greater litter emphasis
- Community education through our Solid Waste Program
