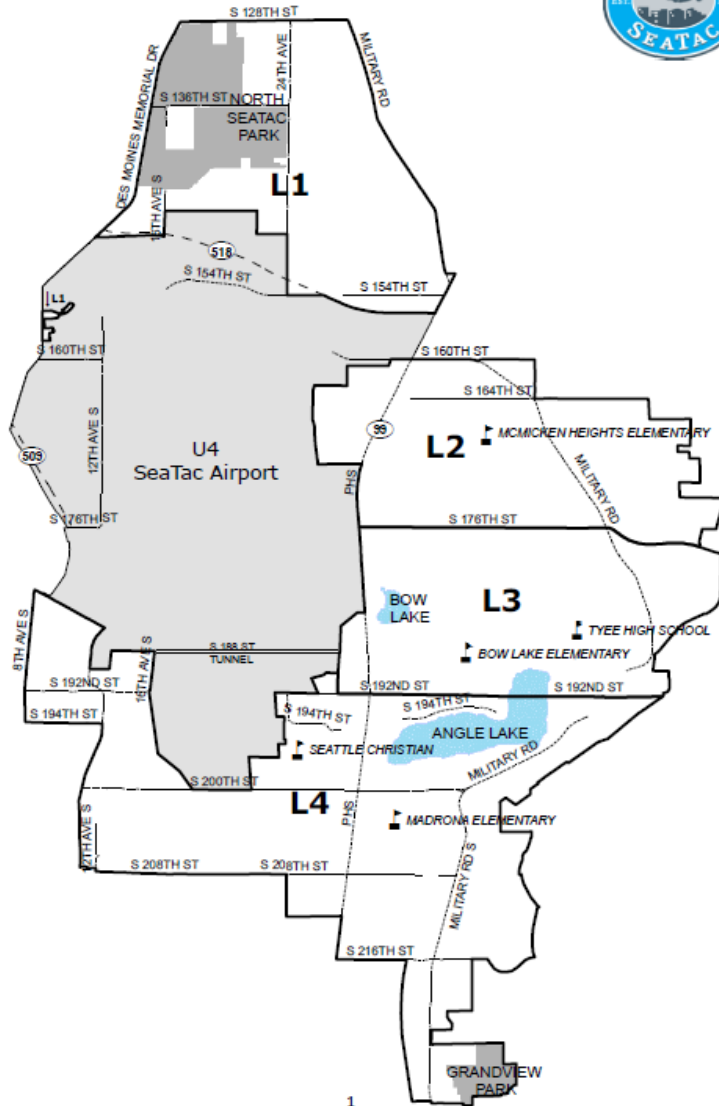
NATIONAL INCIDENT-BASED REPORTING SYSTEM, “NIBRS”

- 1929 – FBI instituted the Uniform Crime Reporting “UCR” method of collecting crime statistics. The Summary UCR method historically recorded and reported only the most serious offense committed in an incident, even though the incident could have involved multiple offenses.
- 1991 – the FBI initiated NIBRS to improve the overall quality of law enforcement crime data and set a date of 2021 for all agencies to be converted to the new method.
- 2018- the King County Sheriff’s Office instituted a new computer program in order to comply with the NIBRS mandate.

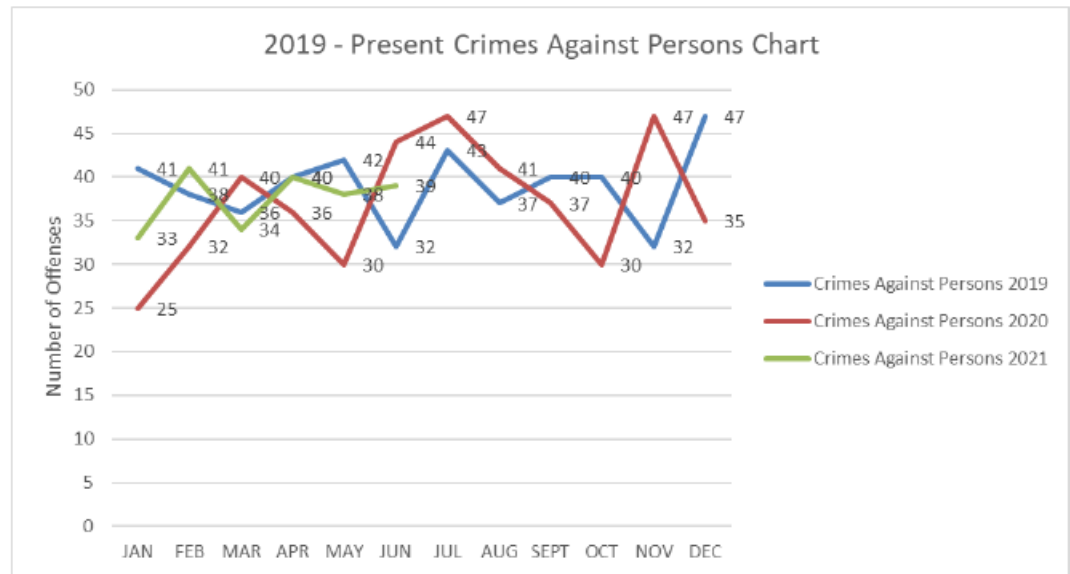

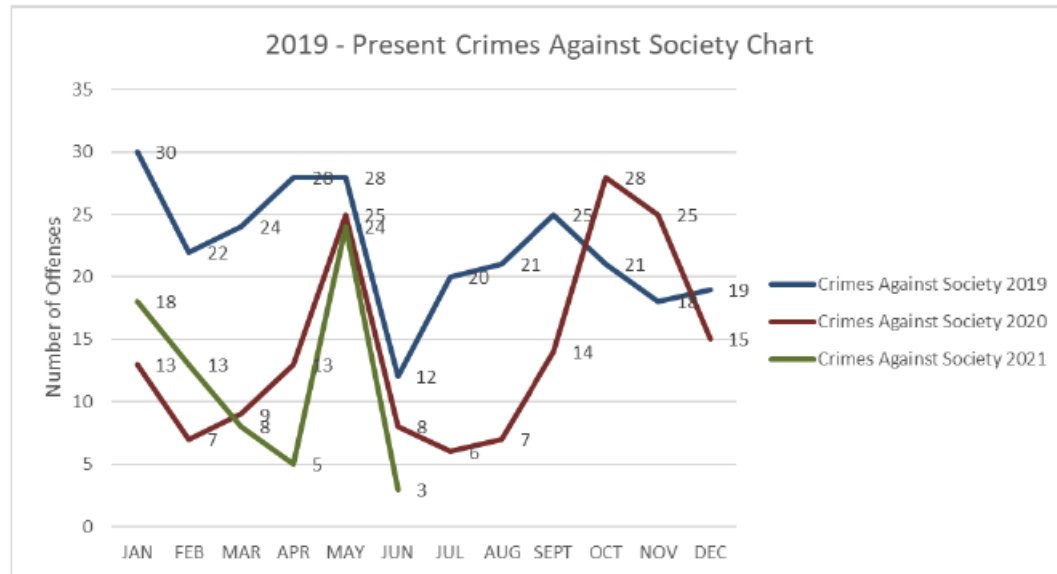

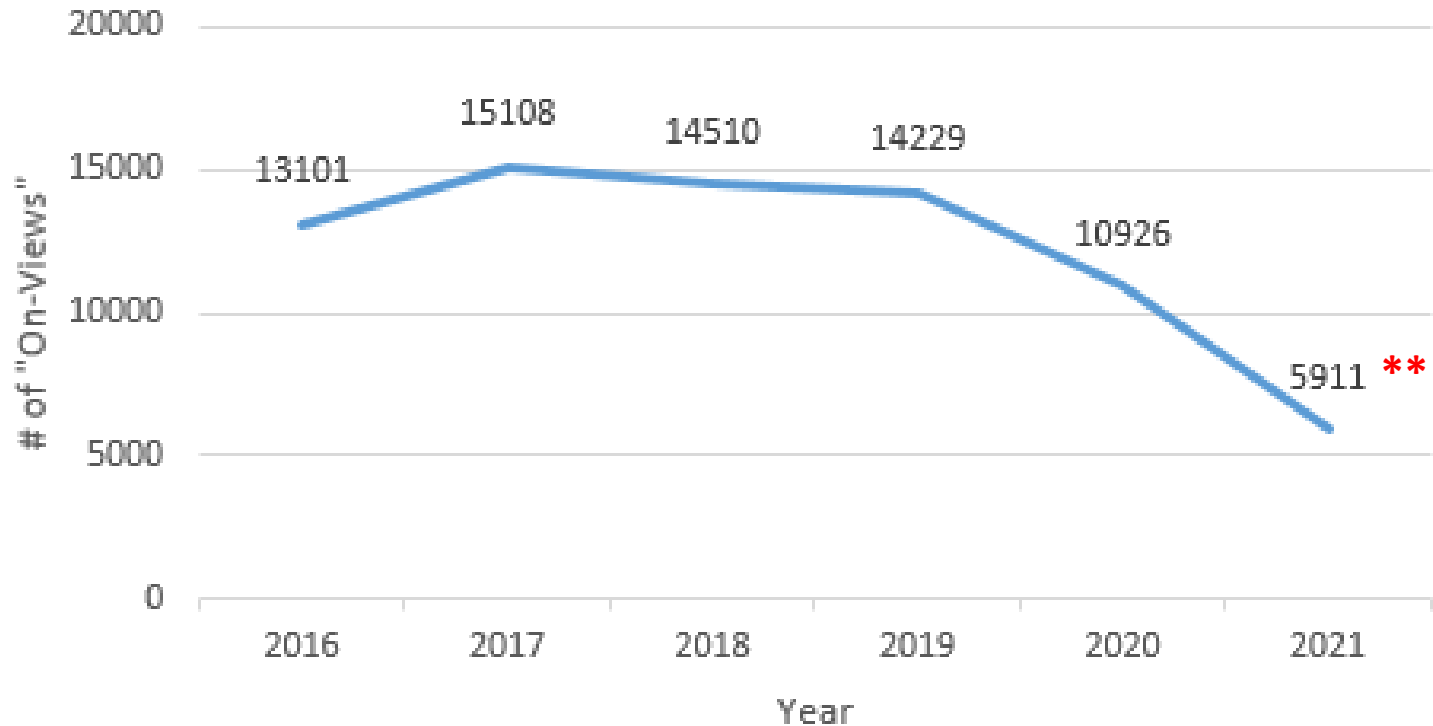

Self-Initiated Police Activity "On-Views"



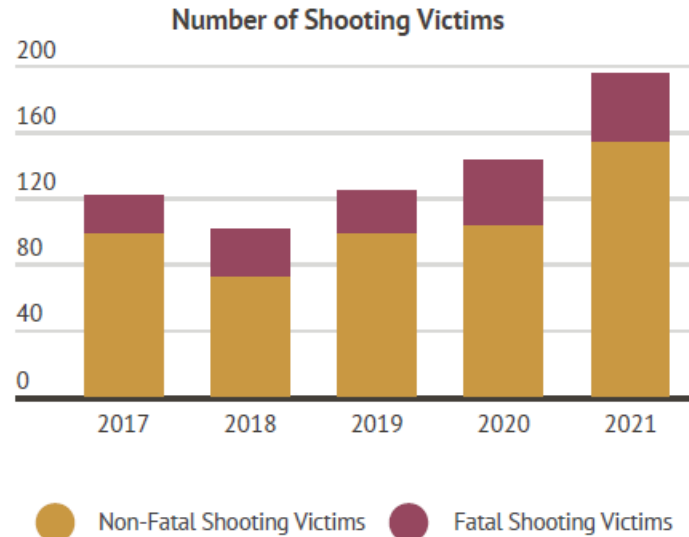
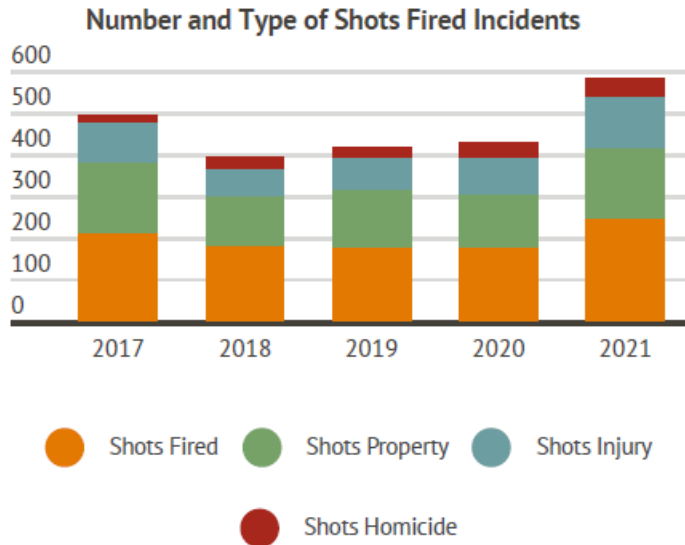

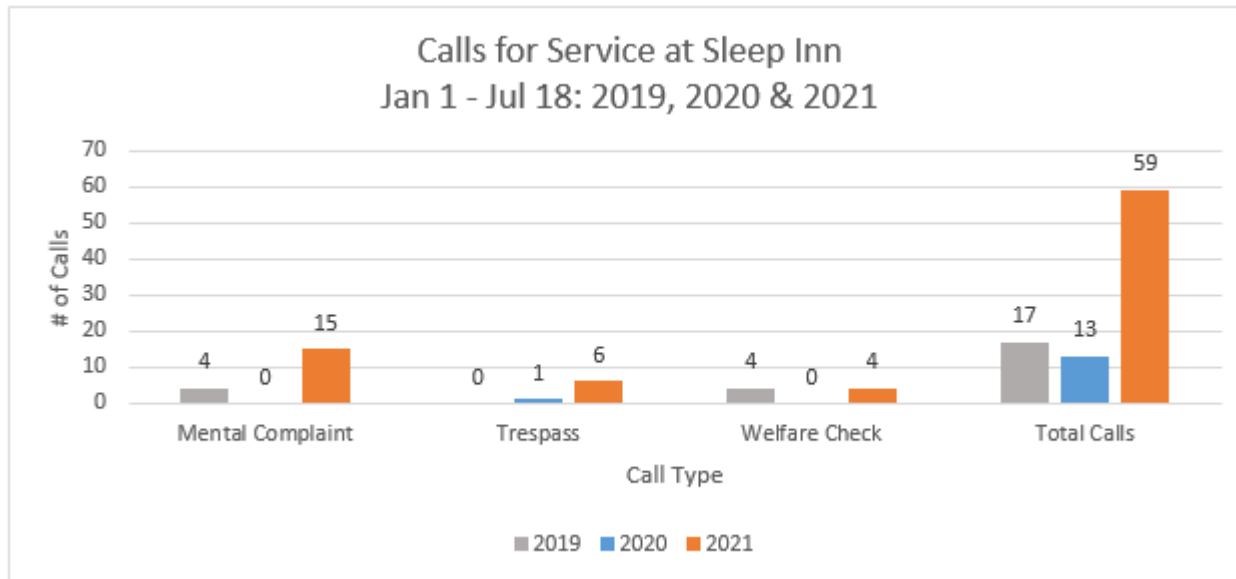

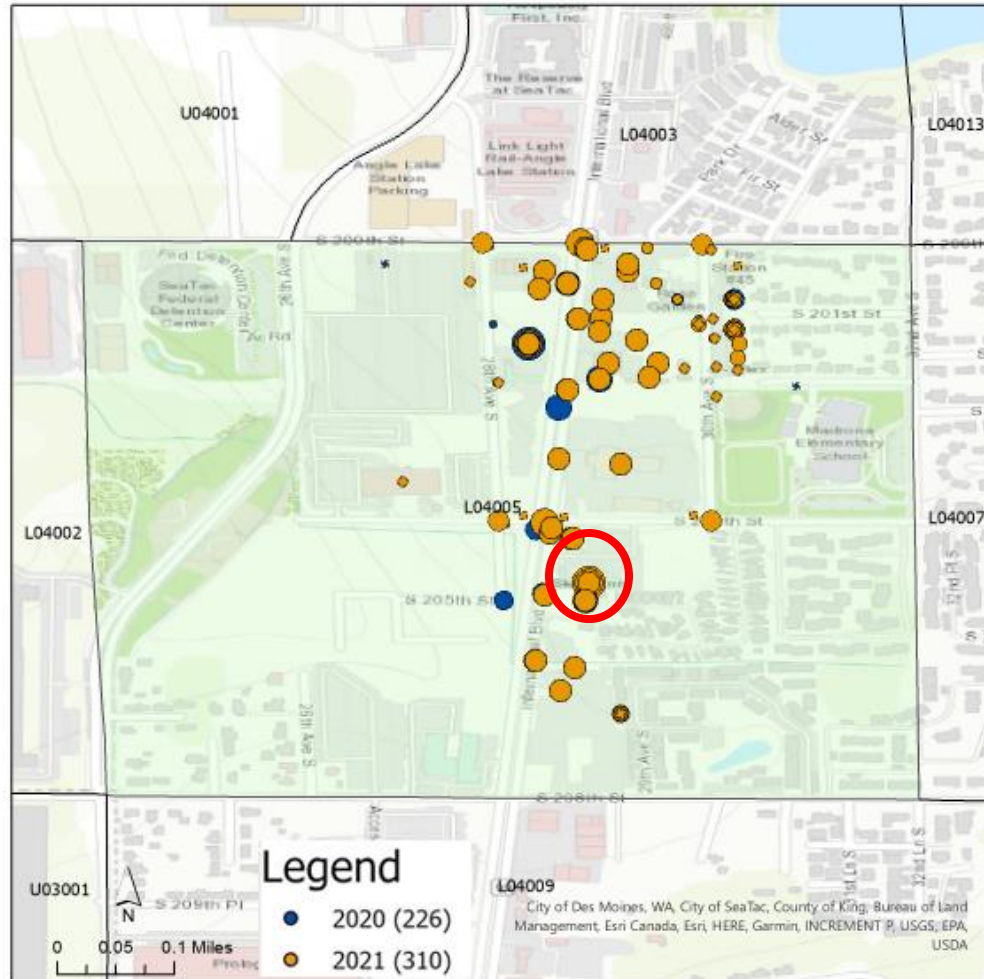

2021 WASHINGTON LEGISLATIVE CHANGES AFFECTING LAW ENFORCEMENT




House Bill 1054

TACTICS

- Prohibits neck restraints and choke holds with exception for deadly force 
- Prohibits No Knock warrants
- Forbids firing from a moving car, except as last resort 
 - Protection of self or others
- Significantly Limits Pursuits 
- Restricts use of tear gas
- Removes military equipment from police

House Bill 1310

USE OF FORCE

- Limits use of force to probable cause situations
- New standard for deadly force – Imminent threat
- Mandates de-escalation prior to force application 
- Mandates minimum required force
 - Seemingly no change
- Requires termination of force
- Attorney General's Office directed to create model policy
 - Deadline July 1, 2022
 - CJTC will train to this bill and AG model policy

Senate Bill 5051

DECERTIFICATION

- Peace Officer certification
- Law enforcement decertification criterion clarified
- Allows CJTC to conduct independent misconduct investigations.
- CJTC has input to agency investigations.
 - Recommend training

Senate Bill 5066

DUTY TO INTERVENE

- Law enforcement officers must intervene and report if they observe the use of excessive force ★
- Duty to report ★
- Includes duty to render first aid ★

House Bill 1267

OFFICE OF INDEPENDENT INVESTIGATIONS (OII)

- Establishes State investigative team for deadly force incidents
- Directs that OII lead investigative body over any investigation it chooses.
- Jurisdiction of OII may expand after assessment period.



House Bill 1089

INVESTIGATION AUDITING

- State Auditor with Criminal Justice Training Commission may conduct a process compliance audit of any deadly force investigation

Senate Bill 5476

AMMENDMENT TO DRUG LAWS AFTER BLAKE DECISION

- Blake decision February 2021
- Adds element of “knowledge” to drug laws
- Makes possession a misdemeanor
 - Essentially makes narcotics paraphernalia legal
- Requires diversion for first two offenses
- Substantial work remains on establishment of police training and diversion resources

House Bill 1140

JUVENILE ACCESS TO COUNSEL

- Law enforcement **MUST** provide access to counsel for
 - Any juvenile
 - Prior to Custodial Interrogation
 - When seeking consent to search
 - Essentially matches current King County Code



House Bill 1223

RECORDING OF CUSTODIAL INTERROGATIONS

- Custodial Interrogation of adults related to felony investigations and all juvenile criminal investigations must be electronically recorded
 - When occurring in law enforcement and detention facilities must be audio AND video recorded



Senate Bill 5259

DATA COLLECTION FOR LAW ENFORCEMENT

- State Attorney General will contract with an institution of higher education to establish and administer a use of force reporting system
 - Data collection requirements and associated logistical and workload issues still unknown

UPDATE ON VIDEO CAMERA REGISTRY

- Continue to contact businesses in SeaTac to inquire about video cameras
- At the same time, offering in person meetings with businesses to assist them in understanding their camera's capabilities and how to retrieve video
