### Awards

There will be \$1,400 available for purchase awards. Works of art will be purchased for the City of SeaTac's permanent collection. To be eligible for the Art Purchase Award, a piece must be for sale at a price not to exceed \$750.

The city will share artist contact information directly with interested parties interested in purchases art.

### Entry Fee

The entry fee is \$20 per entry. Artists may submit up to two entries. The City reserves the right to choose artwork eligible for this exhibit. Artists must place their work on sale.

### Registration

Art registration will be on Monday, October 2 between the hours of 9:00 AM and 6:00 PM at SeaTac Community Center.

### Pickup Art

All work shown in the exhibit must be picked up Friday, October 26, 8:30 AM to 5:00 PM. Art may not be picked up early. Art left will become property of the City of SeaTac. Art not exhibited may be picked up upon notification by postcard.

### Location

### Specifications

Exhibit is for 2 dimensional art work, paintings, drawings, and original prints. No photography. All works must be completely dry, be matted, framed and ready to hang with wire, and may not exceed 3 feet in any direction. Artwork submitted should be appropriate for public display and suitable for community viewing. All pieces submitted must be for sale. Works must be original and not more than two years old.

All works must have a 3 x 5 card attached to the lower right back and must include:

- Artist's name, address, day and evening phone numbers.
- Title of piece, medium, year of execution and price.
