Agenda Bill #5756; A Motion approving the City's 2022 Legislative Agenda.

Summary: The 2022 State Legislative Agenda consists of two documents. The first document is the 2022 Legislative Agenda that contains three to five top priorities for the City at the state level. Gordon Thomas Honeywell (GTH) will proactively seek to accomplish these top priorities.

The second document is the Policy Document (formally referred to as the Internal Legislative Agenda). These are also called "back page items" which gives the City's lobbyist policy direction on issues that will occur during the session. GTH will react to these items when they appear during the legislative session.

The 2022 Legislative Agenda was discussed for the first time at the CSS on September 14, 2021. The second discussion happened at the CSS on October 12, 2021. At the CSS, Council recommended the item be moved to the October 26, Regular Council Meeting (RCM) for consideration and potential action.

Government Relations & Communications Manager Moore introduced GTH Lobbyist Josh Weiss. They reviewed the agenda bill summary.
