Proposals shall be limited to 15 single sided pages excluding cover letter and resumes. Five copies of each statement of qualifications are required.

All submittals will be scored and ranked on the above criteria. Previous experience with a project or projects that involved cleaning litter along roadways is preferred. Interviews will be conducted with the highest ranking firms.

Purpose

The purpose of this work is to clean up litter along freeway/highway access ramps in the City of SeaTac.

Scope of Work

The VENDOR will clean 16 freeway/highway ramps located in the City of SeaTac's limits but within Washington State Department of Transportation jurisdiction. Ramps will be clean during the funding period. These ramps include but may not be limited to:

- On/off ramps North Bound and South Bound Interstate-5 from exits 151-152
- On/off ramps East Bound and West Bound State Route 518 exit to HWY 99, exit to Airport as well as Des Moines Memorial Drive exits
- On/off ramps North Bound and South Bound State Route 509 intersection with south 188th street

VENDOR will take collected litter to a permitted solid waste facility and recycle materials whenever possible.

VENDOR or delegate is responsible for crew safety training and oversight of crewmembers. VENDOR will follow all applicable County or State traffic control procedures as determined by the appropriate County or State officials while working within or along identified roadways. VENDOR will provide appropriate Personal Protective Equipment (PPE) for all their workers. PPE can include Safety Vests, gloves, eye protection, and any other supplies or equipment necessary to complete the work safely.

VENDOR must submit quarterly Payment Request Progress Reports to City of SeaTac. VENDOR is required to report each time:

- Hours worked.
- Miles cleaned.*
- Yards of material collected.
- Number of ramps cleaned.

Task costs:

Eligible costs for reimbursement with supporting documentation include:

- Safety training (with City prior approval).
- Equipment, tools, and supplies needed for safety and cleanup work.
- Staff time, transportation, and disposal of materials cleaned.
- Costs not listed here, but pre-approved in writing by City of SeaTac.

Task Goal Statement:

1) Clean freeway/highway access ramps within City of SeaTac.

Task Expected Outcome:

VENDOR will track and report the:

- 16 access ramps cleaned
- Cleaned ramps converted to 32 miles cleaned.
- 24,000 pounds of litter collected (estimate).

Preparation Costs

The City of SeaTac shall not be responsible for proposal preparation costs, nor for costs including attorney fees associated with any (administrative, judicial or otherwise) challenge to the determination of the highest ranked proposer and/or award of contract and/or rejection of proposal. By submitting a proposal, each proposer agrees to be bound in this respect and waives all claims to such costs and fees.
