WHY IS THIS ISSUE IMPORTANT?

- 1. Hearing Examiner system is established in Chapter 1.20 of the SeaTac Municipal Code to conduct quasi-judicial hearings and issue decisions
- 2. City's Hearing Examiner since 2004 retired at the end of the year.
- 3. City Manager's appointment of new Hearing Examiner requires confirmation by City Council.

- Appeals, conditional use permits, planned unit developments, preliminary subdivisions, variances, shoreline permits, sitespecific rezones etc. (Type III Land Use Permits)
- ☐ Provides a separation from the legislative branch (rule-making) and the executive / judicial branches (rule-enforcement) of government.
- ☐ Reduces local government liability exposure through more consistent and legally defensible quasi-judicial decisions.



APPOINTED HEARING EXAMINER

Andrew Reeves of Sound Law Center selected through RFQ process.
Served as the Hearing Examiner for over 30 jurisdictions in the State.
Held hearings and/or written decisions on over 500 land use, environmental, and administrative law matters.
Resolution authorizes contract for a two-year term with Sound Law Center and Mr. Reeves for Hearing Examiner and Hearing Examiner Pro Tem services.
Land use applicants are required to pay for the cost of Hearing Examiner services.
