Review of General Fund (GF) Forecast Update: Finance Director McCarty reviewed the GF status.

Decision cards proposed to be funded in the 2011 Preliminary Budget total \$44,615 in the GF and \$48,800 in other City funds.

ICM Cutts stated that there are revenue options to be considered going forward, including a 1% Utility Tax which would generate approximately \$440,000 a year. Council discussion ensued as to this option with most CMs agreeing that this is not the year to implement any tax increases.

Mr. Cutts clarified that this option was not included as part of the City Manager's budget recommendation.

2011 Property Tax Levy: Finance Director McCarty stated that the City still hasn't received finalized numbers from King County (KC). The preliminary allowable levy is \$11.8 million and the maximum statutory levy is \$13.6 million. The City is still waiting to receive the increase in utility value, which won't be available until after Thanksgiving. However, SeaTac is required to submit the City's Property Tax Levy to KC by December 3.

Staff will provide a tentative levy Ordinance for Council to vote on at the November 23, 2010 Regular Council Meeting (RCM) using the maximum statutory levy of \$13.6 million because the Council can only lower the rate, not increase the rate later. Staff will then prepare an Ordinance for the December 14 RCM for Council to rescind the tentative levy and establish the new levy.

2011 Budget Timeline: ICM Cutts handed out the timeline for Council review, which included Council budget dates, administrative actions/deadlines, and layoff related information.

Upon a question posed by Mayor T. Anderson, HR Director Hoang stated that staff researched providing early retirement incentives, but determined it would be cost prohibitive.

Upon a question posed by DM Fisher, Ms. Hoang stated that the City just signed a Letter Of Understanding (LOU) with the American Federation of State, County and Municipal Employees (AFSCME) Union determining bumping rights. Employees can bump down, but not up.
