**APPROVAL OF MINUTES:** Minutes dated May 17, 2022, were approved as written.

Human Services will be supporting the cost of the single serve salads up to \$1,500.00 in food supplies for the remainder of the year. **MONEY MANAGEMENT UPDATE:** Provided statements for April and May, 2022. The Senior Program Fund at the Renton Foundation has taken a hit due to recent market trends.

**PURCHASES:** The fountain for the sensory garden currently being installed by Facilities and Park Maintenance Staff. The total purchase amount of \$1,728.55 will be deducted from the Renton Foundation fund at the end of the year.

**NEW BUSINESS:** Discussion and request for gift cards for the remaining monthly birthday parties and the My Senior Center "Sign In & Win drawing. We are requesting two \$10.00 Fred Meyer gift cards for each Birthday Party (July-December 2022), which would make 12 cards and a cost of \$120.00. We are requesting Ten \$10.00 for the My Senior Center "Sign In & Win" drawings, which would cost \$100.00. The total cost for 22 \$10.00 Gift Cards to Fred Meyers would be \$220.00.
