2nd Quarter Police Stats Presentation.

Police Chief Mattsen reviewed 2022 SeaTac Police Department Goals, Police Department Organizational Chart, and 2022 1st and 2nd quarter crime statistics. Residential burglaries have decreased from 31 to 7 from 1st to 2nd quarter. Auto thefts were high in quarter 1.

Chief Mattsen reviewed overdose deaths, firearm violence, de-intensification shelters in SeaTac have closed, north City satellite office, 2022 National Night Out, and new camera tower.

ACTION ITEMS (continued):

Agenda Bill #6046; An Ordinance #22-1012 amending Title 8.10.010 of the SeaTac Municipal Code (SMC) by repealing the adoption of the former Chapter 26.50 of the Revise Code of Washington (RCW) and adopting by reference certain Sections of the new Chapter 7.105 RCW related to laws governing prevention and enforcement of protection orders.

Summary: Recently, the State Legislature passed Engrossed Substitute House Bill (ESHB) 1320 which pertains to "modernizing, harmonizing, and improving the efficacy and accessibility of laws concerning civil protection orders". ESHB 1320 consolidated laws governing domestic violence protection orders, sexual assault protection orders, stalking protection orders, anti-harassment protection orders, vulnerable adult protection orders, and extreme risk protection orders under one Chapter, 7.105 RCW. Further, ESHB 1320 repealed over 100 sections of the RCW pertaining to the same laws.

In order for the City to continue prosecuting violations of such Court orders, the Council must adopt an Ordinance amending the SeaTac Municipal Code by adding relevant newly adopted Sections of 7.105 RCW and repealing language related to the adoption of former Chapter 26.50 RCW, which has now been repealed by the legislation.

Senior Assistant City Attorney Corsilles reviewed the agenda bill summary.

MOVED BY KWON, SECONDED BY GUZMÁN TO PASS AGENDA BILL #6046 (ORDINANCE #22-1012).*

Council discussion ensued regarding their support of this item.
