I have already given comments during the previous DOC Zoom meetings with the city and won't repeat them here at this time.

Besides already having more than our share of public essential facilities in our small city, the City of SeaTac needs to be concerned with the safety of its' residents, and the negative economic effect that a halfway house could bring when travelers and visitors and convention goers realize the close proximity of a halfway house. (You can use Re Entry Facility if you'd like, but it is still incarceration).

Not saying that this program can't be beneficial for some, and I wish them success. People can, and have turned their lives around--even without halfway houses. But I am thinking of our entire city and want to thoroughly weigh the pros and cons of a halfway house and all of the ways it could/would affect our resident population. We need to be very, very thoughtful and prudent in this matter.

Halfway houses/work release facilities are not are not a given--and remember, being in a halfway house/work release facility is STILL considered being incarcerated! Please keep foremost in your thinking the safety of our residents and the economic vitality of our city. Please be sure to read data I have included which alerts us to the lack of transparency and lack of oversight of such facilities.

Can our staff or the DOC can show us a models of halfway houses that are run in an accountable, open and transparent manner? If so, I would like to see the information.

Maybe this issue should be a ballot issue so that SeaTac residents can weigh in on it.

If this halfway house issue moves forward to the council, will there be a public meeting?
