ACTION ITEMS:

Agenda Bill #6090; A Motion confirming appointments to the Seattle Southside Regional Tourism Authority (SSRTA) Board of Directors.

Summary: The City Council passed Ordinance #14-1014 on October 14, 2014, chartering the SSRTA. The main purpose for creating the SSRTA was to allow hotels with 90 or more rooms to impose a special self-assessment of \$2.00 per room night, which would be used to expand tourism promotion services by SSRTA. When the SSRTA was formed, the SeaTac City Council was designated by the three participating cities (SeaTac, Tukwila, and Des Moines) as the Legislative Authority.

The SSRTA Charter provides that new appointments and re-appointments to the Board are to be made by the existing Board, subject to confirmation by the City Council. The Board is to be comprised primarily (but not exclusively) of ratepayer representatives of the lodging industry covering a variety of geographic locations, property sizes and price points of lodging businesses within the defined tourism promotion area.

ED Strategist Carter introduced SSRTA President & CEO Mark Everton. Ms. Carter reviewed the agenda bill summary.

Council discussion ensued regarding the appointments.

Agenda Bill #5663; A Resolution #22-016 authorizing the City Manager to enter into a consolidated Transit Way Agreement (TWA) between the City of SeaTac and Sound Transit, thereby consolidating three existing TWAs into one agreement.

Summary: Currently, there are three major TWAs between the Parties that regulate Sound Transit's use of the City's right-of-way (ROW) for the purposes of constructing, operating, and maintaining light rail within the City. These agreements span between 2006 – 2019 and contain different language reflecting processes and procedures that were relevant at the time each agreement was executed. As a result, each agreement has slightly different requirements for each segment of the system including, but not limited to, maintenance, general operations, emergencies, notification periods, and permitting.

At the City's request, the Parties have worked to consolidate the three existing TWAs into one document, using the most recent TWA for the Federal Way Link Extension as the model text. The purpose of this consolidated TWA is to align language and provide for one agreement to address the entire transit line within the City limits. The proposed consolidated agreement has been thoroughly reviewed by both Parties. No new changes are proposed as part of this consolidated agreement that deviate from previous agreements reviewed and approved by Council.

Approval of this Resolution will authorize the City Manager to enter into a consolidated TWA following review of the agreement by the Federal Transit Administration and Sound Transit Board (anticipated to be completed by December 2022). Once executed, the consolidated TWA will be the agreement used by both Parties to address the continued maintenance and operation of light rail within portions of the City's ROW.

This topic was discussed at the September 15 and October 6, 2022 Transportation and Public Works (T&PW) Committee meetings. The Committee recommended forwarding the agreement to Council for approval.

Senior Management Analyst Woodmass reviewed the agenda bill summary.

MOVED BY KWON, SECONDED BY EGAL TO PASS AGENDA BILL #5663 (RESOLUTION #22-016).*

Council discussion ensued regarding the T&PW Committee review and the benefit of this consolidation.

ACTION ITEMS (continued):

Agenda Bill #6070; A Resolution #22-017 amending the City Council Administrative Procedures to allow for hybrid Council meetings.

Summary: Effective October 31, 2022, the COVID Emergency proclamation will be lifted. The current Council Administrative Procedures do not allow for more than three members to participate in Council meetings remotely without an emergency. This Resolution approves revisions to the Council Administrative Procedures to continue with the current practice of hybrid meetings once the emergency is no longer in place.

In addition to adding language throughout the procedures related to hybrid meetings, the following is a summary of the additional changes:

Section 3. Council Committees and Representatives

- Ad Hoc Committees: added language clarifying the process
- Local, Regional, State, Other Committees: added language clarifying the process
- Standing Committees: added language clarifying the process
- Parliamentary Procedures: removed the details of this section because in many cases it appears to have added too much structure/formality.

Section 5. Format for Agendas for Council Meetings:

- Public comments: added language for hybrid meetings and removed public comments for Unfinished Business.
- Consent Agenda: revised/added language regarding the grant application and acceptance process
- New Business: removed this section (new items go through the Council Request Form process, and with hybrid remote public comment option, remote participants would not have an opportunity to comment on new items)

Section 6. Miscellaneous Agenda Procedures

Councilmember absences: defined how excused/unexcused absences are handled at RCMs.

Section 7. Speaking Procedures

• Removed language which affects freedom of speech.

Section 9. Voting

• Removed the requirement for Council to be physically present

Section 11. Council Relations with Staff

• Council Request Forms: revised language to match current process

Section 14. Executive Sessions:

- Removed the requirement to be physically present
- Added hybrid format language

Exhibit C. Automatic Referrals:

- Added topics
- Added Council Study Sessions (CSS)
- Added RCMs
