South King County and this area of Burien, White Center, SeaTac, Tukwila, is lacking in access to green space. The Council's action to acquire and protect North SeaTac Park in its entirety, and preserve it as a Park in perpetuity, is a critical step in serving the community by supporting the health of our citizens, mitigating the noise and pollution impacts by the airport, and promoting restoration and health of the watershed.

This park is a regional treasure. To quote Lawrence Ellis, Director of SeaTac's Parks, Community Programs & Services in his background memo for this resolution, the park is "recognized as one of the largest open spaces in South King County that preserves a portion of the community's natural environment and promotes the quality of life for the SeaTac residents and surrounding communities that benefit from the use of the park."

No part of this park should be commercially developed. According to the FAA, it was created to compensate area residents for cumulative impacts of SeaTac Airport. The impacts by the airport are increasing, the airport must be held accountable for these impacts, and the airport should examine how to operate efficiently within its current developed areas before consuming more green space. With city ownership of the park and strong legal protections for its continued use as a park and the health of its forest and waterways, the city would have the ability to appropriately plan and invest in its protection.

Thank you for making the preservation of North SeaTac Park a priority.
