Finance & Systems Director Pilo reviewed the agenda bill summary below.

Agenda Bill #6085; An Ordinance #22-1021 authorizing the City's 2023 Property Tax Levy.

Summary: Cities must submit their authorized levy amounts to the King County (KC) Assessor's Office by November 30, 2022, for inclusion in KC's 2023 property tax roll. The KC Assessor's Office is not expected to certify the City's assessed valuation (AV) prior to their November 30, 2022 deadline.

The total estimated allowable statutory levy amount including new construction, estimates of refunds and utility valuations is \$25,782,977. The City can only increase the property tax levy by the 101% limit factor or the Implicit Price Deflator (IPD) whichever is less. This year's IPD is 6.457%, so the maximum amount the levy can increase is limited to 1%, which means, based off the most recent information from the KC Assessor, the City could levy \$18,767,507. However, the Council adopted Financial Policies establish that as long as the General Fund (GF) Reserves are within the set reserve target (4-months), the City will not increase its property tax levy. Therefore, a zero percent (0%) increase over the 2022 amount, plus revenue from new construction and prior year refunds, has been applied in development of the 2023-2024 Biennial Budget.

The KC Assessor has given the City a preliminary estimate of the City's 2023 assessed value equal to \$7.661 billion, an 8.7% increase over 2022. This preliminary estimate excludes the final valuation of any state assessed utilities. Because the actual 2023 Levy Rate is calculated from the KC certified AV, the final rate is unknown at this time. However, based on the City proceeding with a 0% increase, it is anticipated the levy rate will decrease from \$2.503/\$1,000 AV levied in 2022 to \$2.310/\$1,000 AV for 2023. This decrease in levy rate translates to a \$19.00 decrease in property tax per \$100,000 AV. The actual increase or decrease in property taxes is dependent upon the actual change in a particular property's AV.

This Ordinance authorizes a 2023 property tax levy amount of \$17,694,662 based on a rate of \$2.310/\$1,000 AV and a 0% increase over the 2022 levy. The actual levy amount will be determined when the KC Assessor certifies the City's total AV in December.

This was reviewed at Budget Workshop #3 on October 22, 2022. The required PH is scheduled for November 8, 2022.

PUBLIC HEARING (PH) & ACTION ITEM (continued):

Agenda Bill #6086; An Ordinance #22-1022 adopting the City's 2023-2024 Biennial Budget.

Summary: This Ordinance adopts the 2023-2024 Biennial Budget. The budgeted revenue and expenditure amounts are based on the preliminary budget presented by the City Manager on October 1, 2022 and modified by the City Council during the budget workshops in October. In accordance with Washington State law, public notice was issued following the filing of the preliminary budget for two consecutive weeks prior to the PH on the City Council's preliminary budget scheduled for November 8, 2022. Following the PH on the budget and the property tax levy rate, the City Council may adopt the City's 2023-2024 Biennial Budget.

The budget appropriations are consistent with City Council direction on what to include in the development of the City's Preliminary 2023-2024 Biennial Budget. The Preliminary 2023-2024 Biennial Budget maintains current service levels and provides increase to some service levels through approved decision cards, utilizing two months of excess reserves while fully funding the 33% (4-month) strategic operating reserve for the GF. This Ordinance adopts by reference the 6-year Capital Improvement Plan (CIP), the salary schedule for City employees, including any adjustments and COLA.

This Ordinance provides for a total appropriation of all city funds for the biennium of \$265.1 million.

The City Council reviewed the budget and CIP at the budget workshops on October 5, 15, and 22, 2022.

MOVED BY NEGUSSE, SECONDED BY GUZMÁN TO AMEND THE BUDGET DECISION CARD FOR A FEASIBILITY STUDY OF A MULTIFAMILY RENTAL HOUSING INSPECTION PROGRAM TO REQUIRE THAT THE CITY'S CONSULTANTS IDENTIFY SEATAC POLICIES RELATED TO HOUSING STABILITY, LIVING STANDARDS, AND TENANT / LANDLORD / RENTER POLICIES. THE CONSULTANT SHOULD ALSO CONDUCT A LANDSCAPE ANALYSIS OF SUCCESSFUL PROGRAMS IN PEER JURISDICTIONS. FINALLY, THE GOAL OF THE STUDY SHOULD BE AMENDED TO INCLUDE A RECOMMENDATION FOR IMPLEMENTATION OF THE MULTIFAMILY HOUSING INSPECTION PROGRAM AND FOR SUCCESSFUL POLICIES THAT PROMOTE HOUSING STABILITY / LIVABLE STANDARDS, AND PREVENT EVICTIONS.**

Council discussion ensued regarding the amendment.

Summary: The Legislative Agenda gives the Government Relations & Communications Manager and City Lobbyist, Gordon Thomas Honeywell (GTH), direction on which legislative issues to actively advocate for and which issues to react to during the legislative session.

The 2023 State Legislative Agenda consists of two documents. The first document is the 2023 Legislative Agenda that contains three to five top priorities for the City at the state level. GTH will proactively seek to accomplish these top priorities. The second document is the 2023 Policy Document (formally referred to as the Internal Legislative Agenda). These are also called "back-page items" which gives the City's lobbyist policy direction on issues that will occur during the session. GTH will react to these items when they appear during the legislative session. These documents are combined into one attachment.

The 2023 Legislative Agenda was presented for discussion at the September 13 and October 25, 2022 CSSs. Council recommended the item be sent to the November 8, 2022 Regular Council Meeting (RCM) as an Action Item.

Government Relations & Communications Manager Kyle Moore and GTH Lobbyists Josh Weiss reviewed the agenda.
