City Engineer reports to the Public Works Director who reports to the City Manager. All major decisions pertaining to the transportation issues are made by the City Council, City Manager, Public Works Director, and the City's Transportation and Public Works Committee. The Transportation and Public Works Committee is comprised of three SeaTac Councilmembers. The name of the City Manager, Public Works Director, and Councilmembers are included in this report. Military Road Five-Way Intersection Study

The City is conducting a study of an intersection to determine the best long-term treatment to manage all modes of travel. Two rounds of outreach were conducted. In the first round, through a partnership between the Public Works Department and the Planning and Economic Development Divisions of the CED Department, door-to-door outreach was conducted near the intersection. Staff visited individual businesses, sharing information about the upcoming study, the pavement overlay project occurring at the intersection the coming summer, as well as general business assistance resources the City provides.

The second round of outreach comprised of an online open house, which presented the three different alternatives being analyzed and contained a survey to solicit attendees' opinion on them. The open house was available to be translated into different languages and compatible with screen readers. Postcards advertising the online open house were mailed to residents and businesses within a quarter mile of the intersection ahead of the open house start date, and it was publicized via the City's blog, social media channels, and with a banner on the City's homepage.

The outreach was successful, with 20 businesses directly visited and 460 individuals visiting the online open house; of those, 138 individuals completed the survey.

South 200th Street Corridor Study

The City is conducting a study of a corridor to determine the best long-term treatment to manage all modes of travel through it. The corridor connects a light rail station with interstate entrance and exit ramps, with single-family homes in between. One round of outreach was conducted during this

reporting period via an interactive web map, where people could leave comments associated with a particular geographic area. The study website was advertised by a postcard mailing and yard signs.

 - I. International BLVD Pedestrian Safety Study
 - a. <u>Data Sources</u> Citywide collision date was provided by Washington State Department of Transportation, an online survey was sent out to the community and stakeholder interviews were used to collect information from users of International BLVD. _
 - b. <u>Summary of demographic data</u> The stakeholders include a diverse group of individuals including New Futures, Living Well, Metro, Hilton Hotels, Global2Local and Council Members. New Futures is located in our largest section 8 multi-family complex and represents some opinions from low-income individuals. Living Well seeks to achieve health equity through policy, systems, and environmental (PSE) change to reduce disparities and increase the opportunities to make healthy lives. The survey was translated into three languages, Spanish, Amharic and Somali based on the most recent census data.
 - c. <u>How data was applied</u> This data was compiled into a report with cost benefit analysis on ways
 to improve pedestrians' safety along International Boulevard.
 - II. Local Road Safety Study
 - a. <u>Data Sources Citywide</u> collision date was provided by Washington State Department of Transportation, an online survey was sent out to the community and stakeholder interviews were used to collect information from users of City streets.
 - b. Summary of demographic data The stakeholders include a diverse group of individuals including African Community Development, Partner in Employment, King County Housing Authority, Sound Transit, Glacier Middle School, Port of Seattle, King County Metro and South Side Chamber of Commerce. The survey was translated into four languages, Spanish, Amharic, Punjab and Somali based on the most recent census data. A postcard encouraging participation in the survey was sent to every address in the City. A flyer requesting participation in the survey was also posted at the main lunchroom for taxi drivers, the international market, the bus stops for airport workers and a Halal grocery store. The survey was also advertised on our City Website Homepage, and on our social media pages. 310 survey responses were gathered with 301 in English, 7 in Amharic and 2 in Spanish.

c. <u>How data was applied</u> – The data is currently being compiled into a report with a cost benefit analysis on ways to improve road safety for all modes of transportation within the City.

III. Military Road Five-Way Intersection Study

- a. <u>Data Sources</u> Safety and traffic data, such as WSDOT collision data, traffic counts from IDAX, and video analysis from Street Simplified, was acquired. An online survey was sent out to the surrounding community to get their opinion on the intersection options and demographic data.
- b. <u>Summary of demographic data</u> The majority (70%) of respondents traveled through the intersection daily, and most travel through the intersection by car. Among participants who chose to identify their ethnicity/race, 69% identified as White and/or Caucasian alone. Ninety-one percent (91%) of respondents primarily speak English in their home. Most respondents were 30 years or older, with the largest represented age group being those 60 years or older (30%).
- c. <u>How data was applied</u> The data was compiled into a summary report that was attached as an appendix to the final report. The final report uses the data to assist in making a recommendation as to a preferred design treatment at the intersection.

IV. South 200th Street Corridor Study

- a. <u>Data Sources</u> Safety and traffic data, such as WSDOT collision data and traffic counts from IDAX were acquired. An online survey is being sent out to the surrounding community to get their opinion on the corridor options and demographic data.
- b. Summary of demographic data the survey results have not been received yet, but our questions concern race, ethnicity, language, whether children under 18 are part of the household, and whether the respondent lives, works, owns a business, or other, in the city.
- c. <u>How data was applied</u> The data will be compiled into a summary report that will be part of the final report. The final report will use the data to assist in making a recommendation as to a preferred design treatment for the corridor.

The City of SeaTac advertises the request for bids for construction projects in the Seattle Times and the Daily Journal of Commerce (DJC) at least twice for each project with the first advertisement 21 calendar days prior to the date which bids will be received. Bid documents are made available to prospective bidders on the Builders Exchange of Washington (BXWA) website where they can be downloaded. Each bid package contains a 'Notice to Contractors' that details how and when bids are to be received and opened. Bid openings have traditionally been held in-person at City Hall, however, COVID-19 has led the City to hold virtual bid openings as of late. Bids are received by the City and read publicly as detailed on the Notice to Contractors.

Upon establishing the apparent low bidder, bids are evaluated and verified by City staff and bid tabulations exceeding \$50,000 are presented to the Transportation and Public Works Committee for authorization to bring a motion to the next Regular Council Meeting for award of the construction contract. When the award for construction is presented at the Regular Council Meeting, City Council has the option to either accept or reject the construction contract and provide recommendation to City staff for next steps. Both TPW and Regular Council Meetings are held publicly and bid tabulations are uploaded to the BXWA website and provided to the DJC for public viewing as soon as City staff has verified the bids.

For small works construction contracts (estimated contract amounts less than \$350,000 per RCW 39.04.155) the City utilizes MRSC Rosters to request quotes and award contracts. During this period, the City did not have any small works construction contracts.

When selecting consultants that will provide professional services, such as design and construction management support, the City staff either sends Requests for Qualifications (RFQ) to at least three consultants, download Statements of Qualifications (SOQ) for consultants listed on MRSC Rosters, or advertise in the Seattle Times for professional services once per week for 2 consecutive weeks with a 3-week response time. Upon identifying at least three consultants that meet qualification requirements, each consultant team is interviewed by City staff. Each consultant team provides a 10-minute presentation followed by a question-and-answer period. City staff asks each consultant team the same set of questions. Each question is scored on a scale of 10 points. Upon concluding all interviews, City staff tabulates all question scoring and selects the consultant team with the highest score. The consultant team selected by the City then provides and scope and fee document to staff that breaks down all required tasks. Based on this document, City staff will negotiate the final contract amount based on historical consulting contracts and the anticipated level of effort.
