
Des Moines Creek Park Trailhead

Description:


The City of SeaTac proposes a new trailhead off 18th Ave S with a vehicular parking area, bioretention swales, forest revegetation, a picnic pavilion, educational signage, restrooms, bike parking, a nature playground, and trails to enhance access to Des Moines Creek Trail and the intersection of 18th Ave and S 200th St. Additionally, the project proposes closing off vehicular access to the existing trail access and parking area off S 200th St. The trailhead park and forest revegetation will provide connectivity to the Lake to Sound Trail and enhance recreational access for the surrounding underserved community.
