Knowing the risks, and in consideration of being permitted to participate in the Adopt-A-Trail program, I, for myself and my personal representative, heirs and assigns, do hereby hold harmless and release, waive, discharge and covenant not to sue the City of SeaTac, it's officers or employees from any and all claims to liability on account of death or injury to person or property of the undersigned of any kind or nature whatsoever arising out of, or in any way connected with, the undersigned's participation in the Adopt-A-Trail program, even though a claim or liability may arise out of a condition of the premises or the past or future negligence or carelessness on the part of the City of SeaTac, its officials, agents, and employees or any third person, whether foreseen or unforeseen, known or unknown.

The undersigned hereby expressly agrees that this release and waiver is intended to be as broad and inclusive as permitted by the laws of the state of Washington and that if any portion hereof is held invalid, it is agreed that the balance, not withstanding, continue in full legal force and effect.

The undersigned further states that he/she has carefully read the foregoing Release and Waiver of Liability, knows the contents thereof, and has agreed to sign this Release and Waiver of Liability as his/her own free act and deed.
