ACTION ITEMS:

Agenda Bill #6147; A Motion authorizing the City Manager to enter into an Interlocal Agreement (ILA) between SeaTac and Normandy Park related to electrical permit services.

Summary: Burien has historically provided construction permitting services, including for electrical permits and inspections, to the City of Normandy Park. In the Fall of 2022, Burien indicated it could no longer provide electrical permitting services to Normandy Park. Normandy Park staff approached SeaTac staff to discuss a possible ILA for electrical permitting services in late 2022.

Electrical permits and inspections are heavily regulated by the State of Washington Department of Labor and Industries (L&I) and may only be performed by plans examiners and inspectors who are licensed journeyman electricians or possess state-mandated qualifications. If Normandy Park is unable to enter into an ILA with SeaTac for electrical permitting services, it is likely that all electrical permits and inspections in Normandy Park will be processed by L&I, which will result in significant delays.

SeaTac currently employs three combination plans examiners / inspectors, two of which are licensed under State law to provide electrical permit services. The volume of electrical permits and inspections in Normandy Park does not appear to represent a significant increase in workload for SeaTac. SeaTac will confirm that this assumption is accurate during the 6-month trial period. Presuming it makes sense for the cities to continue the partnership, staff will request City Council approval of a longer ILA at the end of the 6-month temporary ILA.

Normandy Park will collect permit fees for all electrical permitting services and shall pay SeaTac at the rate established by the SeaTac City Council in its fee schedule.

The A&F committee reviewed this item on January 12, 2023 and recommended that the City Council pass a motion authorizing the City Manager to enter into the ILA.

Agenda Bill #6144; A Resolution #23-001 adopting a Roadside Memorial Sign Policy for the City of SeaTac. Summary: The community of SeaTac has expressed an interest in roadside memorials for those who have lost their lives in the right-of-way (ROW) due to accidents caused by distracted driving, driving under the influence, or other causes. The Roadside Memorial Sign Policy allows for signs to be installed and maintained for a period of five years in memory of an individual victim to a fatality accident. Signs will include an important safety message and a plaque with the deceased individual's name or the name of the sponsoring family.

The Roadside Memorial Sign Policy allows for appropriate messaging in the ROW while ensuring that safety and maintenance concerns are addressed.

Elements integrated into the Policy include:

- A cost of entry/fee for a memorial.
- A time limit for the memorial.
- Allowance for the memorial element to be returned to the family or family's representative.
- Procedures to minimize clutter and use existing infrastructure.
- Opportunity to use the same memorial more than once.
- Limit to the number of memorials in the ROW.

No impacts to budget are expected. Costs associated with the installation and maintenance of signs are borne by the applicant. The cost for a memorial sign and plaque will be \$500 and the cost for a plaque attached to an existing sign will be \$200.

This item was brought to the July 21 and December 1, 2022, T&PW Committee meetings. The Committee recommended forwarding to the full Council as an action item.

PW Director Appleton reviewed the agenda bill summary.
