PUBLIC HEARING (PH) & ACTION ITEM:

Development Agreement (DA) with MHNW21 Angle Lake Family LLP (Mercy Housing)Mayor Simpson opened the PH at 6:34 p.m.

Planning Manager Kester and Associate Planner Tuttle reviewed the agenda bill summary below.

Council discussion ensued regarding Mercy Housing, the development, and the DA.

Public comments:

The following people spoke in favor of the DA: Allison Simon, Joseph Wilson, and Robin Tatsuda.

Earl Gipson questioned if the land will be subject to property taxes or leasehold tax.

Mayor Simpson closed the PH at 7:05 p.m.

Agenda Bill #6182; A Resolution #23-002 authorizing the City Manager to execute a Development Agreement (DA) with MHNW21 Angle Lake Family LLP (Mercy Housing) for the development of parcel no. 0422049287 Sound Transit surplus property adjacent to the Angle Lake Light Rail Station.

Summary: Under State Statute (RCW 36.70B.170 - .210) and the SeaTac Municipal Code (SMC 15.100.040 and 15.115.030), the City is authorized to negotiate and enter into DAs to set certain parameters under which a project will be implemented. Such DAs can set forth phasing, mitigation, conditions, and development standards. In exchange, the City shall receive public benefits deemed appropriate and commensurate with the benefits provided as part of the DA.

Mercy Housing was selected by Sound Transit as the developer to construct affordable transit-oriented development (TOD). While the use (multi-family) is permitted, a DA is necessary due to deviations requested by Mercy Housing that cannot be approved administratively through the zoning code as a departure or variance. Mercy Housing proposes to develop the property as generally shown on the Site Plan. The project consists of a residential mixed-use building containing 130 units of permanently affordable housing for families earning less than 30%, 50%, and 60% of the area median income, 11,000 Sq. Ft. of ground floor office space for The Arc of KC, a non-profit organization providing services to persons with intellectual and developmental disabilities and a two-level integrated parking garage with approximately 100 parking stalls.

PUBLIC HEARING (PH) & ACTION ITEM:

Agenda Bill #6182; Resolution #23-002 (continued):

Mercy Housing requested the following six deviations from the zoning code:

- 1. Parking reduction. Residential parking provided at a ratio of 0.60 stalls per unit for a total of 78 stalls.
- 2. Minimum front yard setback reduction. Along 26th Avenue South, the minimum front yard setback is two (2) feet.
- 3. Maximum front yard setback increase. Along South 200th Street, twenty (20) feet max setback permitted up to 65% of the buildings front facade.
- 4. Maximum lot coverage increase. Maximum lot coverage of 81%.
- 5. Landscaping reduction. Reduce building facade landscaping width to two (2) feet wide along 26th Avenue South. Eliminate five (5) foot side yard landscaping along the shared access drive.
- 6. Off-Street parking design. Up to 30% of required residential stalls to be provided as compact stalls (8'x16').

The public benefits provided in return for the deviations are:

- 1. Affordable Housing. Approximately 130 units, including 35 additional affordable units 4 additional units for families earning less than 30% of the KC Area Median Income ("AMI") and 31 additional units for families earning less than 60% AMI achieved by the DA. These affordable units will be reserved for low-income families for 99 years under the public and private financing covenants to be recorded on title.
- 2. Family-Sized Housing. Out of the 130 units, approximately 52 are two- and three-bedroom units, including nine (9) additional two and three bedroom units achieved by the DA.
- 3. Housing Reserved for Persons with Disabilities. Approximately 26 units reserved for persons with disabilities, including seven (7) additional units reserved for persons with disabilities achieved by the DA.
- 4. Commercial Space. Mercy Housing will partner with The Arc of KC, which will locate their headquarters in the 11,000 square feet ground floor commercial space to provide onsite and offsite community supportive services to persons with disabilities and their families.
- 5. Bicycle Plaza. A public bicycle plaza along South 200th Street including bicycle storage, bicycle parking, an electronic screen with transit information, a neighborhood and transit map, and bench seating.
- 6. Orca Card. Orca cards provided free of charge for the first three (3) years of operation to each resident who is not otherwise eligible to receive a free Orca card.

Passage of this Resolution has no direct fiscal impact. However, the construction of this project will result in additional revenues such as permit fees.

The PED Committee reviewed the terms of the DA at their January 26, 2023 meeting and recommended the City Council approve the DA. The DA is also being recommended to the City Council by the CED Director and Planning Manager, as required by SMC 15.115.030(D).
